DIGEST OF HB 1046 (Updated March 10, 2015 10:58 am - DI 73)

Citations Affected: Noncode.

Synopsis: Study of sales tax exemptions for bullion or currency. Refers the following questions to the legislative council for assignment to an appropriate interim study committee: (1) Whether sales of precious metals bullion or currency should be exempt from sales tax. (2) Whether the lease of storage for precious metals bullion or currency should be exempt from sales tax.

Effective: July 1, 2015.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE JULY 1, 2015] **(a) The legislative**

3 **interim study committee during the 2015 interim:**
4 **(1) Whether transactions involving the sale of precious metals**
5 **bullion or currency should be exempt from the state gross**
6 **retail tax.**
7 **(2) Whether transactions involving the lease or rental of**
8 **storage for precious metals bullion or currency should be**
9 **exempt from the state gross retail tax.**
10 **(b) This SECTION expires December 31, 2015.**
