DIGEST OF INTRODUCED BILL

Citations Affected: IC 21-12-8.

Synopsis: Public safety workforce development. Provides that a public safety officer may be eligible to receive a high value workforce ready credit-bearing grant (grant). Provides that a public safety officer may receive a grant for a certificate or associate degree program at Ivy Tech Community College or Vincennes University. Provides that a public safety officer applicant must submit proof of employment as a public safety officer to be eligible for the grant. Resolves a conflict between HEA 1074-2018 and HEA 1002-2018. Makes technical corrections.
