Provides that a local economic development organization may enter into a regional holding facility lease agreement with the department of correction to: (1) address the issue of jail overcrowding in Indiana; (2) reduce recidivism by offering programs in an unused department of correction facility; and (3) obtain federal funding to operate the facility. Establishes conditions under which a county sheriff may transfer certain confined jail offenders to a regional holding facility. Establishes requirements for transfer agreements between the department and county sheriffs. Requires the department to collect data and report the outcomes of services provided by a regional holding facility to the legislative council. Provides that reimbursements paid by the state to the county for the costs of incarcerating a confined jail offender shall be used to pay for a confined jail offender housed in either a regional holding facility or a county jail. Provides that the Indiana criminal justice institute shall identify any federal, state, or local grants that can be used to assist in the funding and operation of regional holding facilities. Allows political subdivisions to enter into public-private agreements with an operator to accomplish the design, financing, construction, acquisition, improvement, renovation, equipping, operation, or maintenance of a regional jail. Establishes the county jail overcrowding task force to: (1) conduct a statewide review of jail overcrowding; and (2) study the issue of how to reduce recidivism for convicted felons in county jails by offering programs designed to reduce recidivism. Requires the justice reinvestment advisory council to conduct a statewide review of bail reform and pretrial issues and to identify common reasons and possible local, regional, and statewide solutions.

A BILL FOR AN ACT to amend the Indiana Code concerning corrections.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 4-20.5-7-22 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE  
3 UPON PASSAGE]: **Sec. 22. (a) As used in this section, "local  
4 economic development organization" has the meaning set forth in  
5 IC 5-28-11.5-2.**  
6 **(b) As used in this section, "regional holding facility lease  
7 agreement" means an agreement between the department of  
8 correction and a local economic development organization to lease  
9 an unused department of correction facility for the purpose of:**  
10 **(1) addressing the issue of jail overcrowding in Indiana;**  
11 **(2) reducing recidivism by offering programs in the facility as  
12 described under IC 11-12-6.5-1(d); and**  
13 **(3) obtaining federal funding to operate the facility.**  
14 **(c) The department of correction may enter into a regional  
15 holding facility lease agreement with a local economic development  
16 organization for not more than forty (40) years. The regional  
17 holding facility lease agreement may be renewed.**

5           SECTION 2. IC 5-2-6-3, AS AMENDED BY SEA 238-2019,  
 6 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 7 UPON PASSAGE]: Sec. 3. The institute is established to do the  
 8 following:

9           (1) Evaluate state and local programs associated with:

13           (C) the administration of criminal and juvenile justice.

23           (7) Administer the traffic safety functions assigned to the institute  
 24 under IC 9-27-2.

25           (8) Compile and analyze information and disseminate the  
 26 information to persons who make criminal justice decisions in this  
 27 state.

28           (9) Serve as the criminal justice statistical analysis center for this  
 29 state.

30           (10) Identify grants and other funds that can be used by the  
 31 department of correction to carry out its responsibilities  
 32 concerning sex or violent offender registration under IC 11-8-8.

33           (11) Administer the application and approval process for  
 34 designating an area of a consolidated or second class city as a  
 35 public safety improvement area under IC 36-8-19.5.

36           (12) Administer funds for the support of any sexual offense  
 37 services.

38           (13) Administer funds for the support of domestic violence  
 39 programs.

40           (14) Administer funds to support assistance to victims of human  
 41 sexual trafficking offenses as provided in IC 35-42-3.5-4.

42           (15) Administer the domestic violence prevention and treatment

- 10 **(20) Identify any federal, state, or local grants that can be**
- 11 **used to assist in the funding and operation of regional holding**
- 12 **facilities under IC 11-12-6.5.**

13 SECTION 3. IC 5-23-1-3 IS AMENDED TO READ AS FOLLOWS  
 14 [EFFECTIVE UPON PASSAGE]: Sec. 3. (a) The state or a political  
 15 subdivision may enter into a public-private agreement with an operator  
 16 under the terms of this article.

17 **(b) A joint board or separate entity established under IC 36-1-7**  
 18 **for purposes of the design, financing, construction, acquisition,**  
 19 **improvement, renovation, equipping, operation, and maintenance**  
 20 **of a regional jail under IC 11-12-5.5 may enter into a**  
 21 **public-private agreement with an operator under this article.**

22 SECTION 4. IC 5-23-3-2 IS AMENDED TO READ AS FOLLOWS  
 23 [EFFECTIVE UPON PASSAGE]: Sec. 2. BOT agreements may  
 24 provide the following:

- 25 (1) The design, construction, operation, management,
- 26 maintenance, or financing of the cost of a public facility shall be
- 27 partially or entirely the responsibility of the operator.
- 28 (2) The governmental body ~~shall~~ **may** lease the public facility and
- 29 real property owned by the governmental body upon which the
- 30 public facility is to be located to the operator for a predetermined
- 31 period. **Except as provided in subdivision (7),** the BOT
- 32 agreement must provide for ownership of all improvements by the
- 33 governmental body, unless the governmental body elects to
- 34 provide for ownership of the public facility by the operator during
- 35 the term of the BOT agreement. In this case, ownership reverts
- 36 back to the governmental body upon the termination of the BOT
- 37 agreement.

 10 the costs of maintenance, law enforcement, and other services  
 11 if the services are performed by the governmental body under  
 12 the BOT agreement.

13 (D) An agreed upon return on investment to the operator.

14 (5) The operator may pay the governmental body either a lease  
 15 payment or a percentage of gross revenue per month for the  
 16 operator's operation and use of the public facility.

17 (6) The BOT agreement may require a performance bond and  
 18 provide for the payment of contractors and subcontractors under  
 19 IC 4-13.6-7, IC 5-16-5, or IC 36-1-12, whichever is applicable.

20 **(7) If a regional jail (as defined in IC 11-12-5.5-1) is the**  
 21 **subject of a BOT agreement under this chapter, the operator**  
 22 **and the governmental body may mutually agree that**  
 23 **ownership of the regional jail will remain with the operator**  
 24 **during the term of the BOT agreement and after termination**  
 25 **of the BOT agreement. The governmental body shall pay costs**  
 26 **associated with the design, construction, financing, operation,**  
 27 **management, and maintenance of the regional jail from funds**

13 under IC 36-1-7-3, a regional jail agreement must include terms

16 (2) The acquisition, **design, financing,** construction, leasing,  
17 maintenance, repair, operation, termination of operations, and  
18 administration of the regional jail.

19 (3) The manner in which each participating entity's proportionate

34 (8) The method of resolving disputes among the participating  
35 entities concerning the regional jail agreement, if any such  
36 disputes arise.

37 **(b) Notwithstanding IC 5-23, if a public-private agreement (as**  
38 **defined in IC 5-23-2-13) is entered into to design, finance,**  
39 **construct, maintain, or operate a regional jail, the manner of**  
40 **acquiring, holding, and disposing of real property under the joint**  
41 **agreement may include ownership by the operator of:**

42 **(1) real property on which the regional jail is constructed;**

 2           **(3) all improvements to the regional jail during and after the**

 19           **means a person convicted of a Level 6 felony and sentenced to a**  
 20           **period of imprisonment in a county jail. The term does not include:**

- 21           **(1) a person convicted of a felony other than a Level 6 felony;**  
 22           **or**  
 23           **(2) a person convicted of an offense under IC 9-30-15.5-1.**

24           **(b) As used in this chapter, "overcrowded" means that the**  
 25           **county jail is at one hundred percent (100%) capacity.**

26           **(c) As used in this chapter, "prisoner" means a criminal**  
 27           **offender who is convicted of a crime and is:**

- 28           **(1) serving a sentence for a conviction other than a Level 6**  
 29           **felony conviction; and**  
 30           **(2) committed to the department of correction.**

31           **(d) As used in this chapter, "regional holding facility" means an**  
 32           **existing facility that:**

- 33           **(1) is currently established and operated by the department**  
 34           **for the purpose of housing a confined jail offender from a**  
 35           **county jail when the county jail is overcrowded;**  
 36           **(2) does not include any prisoners from the general prison**  
 37           **population who are committed to the department of**  
 38           **correction;**  
 39           **(3) provides treatment and counseling, if necessary, for the**  
 40           **following:**

- 41           **(A) drug and alcohol abuse; or**  
 42           **(B) emotional or mental problems;**



1 (4) provides education, if necessary, including:

2 (A) remedial programs;

3 (B) programs in preparation for an Indiana high school  
4 equivalency diploma under IC 22-4.1-18; or

5 (C) life skills;

6 (5) provides vocational assessment designed to evaluate a  
7 participant's skill level and aptitudes for vocational and  
8 technical skill development; and

9 (6) provides other evidence based programs designed to  
10 reduce recidivism.

11 (e) As used in this chapter, "regional holding facility  
12 agreement" means an agreement described in section 2 of this  
13 chapter.

14 Sec. 2. (a) Subject to the requirements of this chapter, a county  
15 sheriff may contract with the department to transfer a confined jail  
16 offender from the county jail to a regional holding facility  
17 established and operated by the department if the county jail is  
18 overcrowded.

19 (b) An agreement between the county sheriff and the  
20 department may be made under this chapter only if:

21 (1) the confined jail offender is serving a sentence for a Level  
22 6 felony conviction; and

23 (2) the commissioner has agreed to accept custody of the  
24 confined jail offender under a court order or by order of the  
25 county sheriff.

26 (c) Whenever the county jail is no longer overcrowded, the  
27 department may return the confined jail offender from the  
28 regional holding facility to the county jail from which the confined  
29 jail offender was transferred.

30 Sec. 3. When a confined jail offender is transferred under this  
31 chapter, the sheriff of the county from which the confined jail  
32 offender is transferred shall be responsible for transporting the  
33 confined jail offender to and from the regional holding facility. If  
34 the sheriff is unable to adequately protect the confined jail offender  
35 during a transfer, the sheriff may request assistance from any  
36 other law enforcement agency.

37 Sec. 4. The costs of incarcerating a confined jail offender under  
38 IC 35-38-3-3(f) shall be used to pay for the confined jail offender  
39 housed in either a regional holding facility or a county jail.

40 Sec. 5. (a) The department shall collect data and report the  
41 outcomes of the services provided under this chapter to the  
42 legislative council in an electronic format under IC 5-14-6 not later



1 than November 1, 2022.

2 (b) The report shall include the following:

3 (1) The number of confined jail offenders served by a regional  
4 holding facility.

5 (2) The average length of time a confined jail offender spent  
6 in a regional holding facility.

7 (3) The number and type of services provided by the regional  
8 holding facility.

9 (4) The number of confined jail offenders demonstrating  
10 improvement in functioning, as defined by the department,  
11 while receiving treatment services in the regional holding  
12 facility.

13 (5) The number of confined jail offenders who did not  
14 recidivate.

15 (6) The number of confined jail offender who did recidivate.

16 (7) A summary description of the most effective service  
17 provided in the regional holding facility.

18 (8) The number of confined jail offenders arrested upon  
19 leaving the regional holding facility and the reason for the  
20 arrest, if known.

21 (9) Recommendations to improve the effectiveness and  
22 efficiency of the program.

23 Sec. 6. The state auditor shall semiannually provide to the  
24 department and the general assembly, in an electronic format  
25 under IC 5-14-6, an itemized record of the per diem and medical  
26 expense reimbursements received by a county under section 4 of  
27 this chapter.

28 Sec. 7. If a confined jail offender is transferred:

29 (1) from a county jail to a regional holding facility, the  
30 confined jail offender's commissary account or trust account  
31 shall be transferred to the department; or

32 (2) from a regional holding facility to a county jail, the  
33 confined jail offender's commissary account or trust account  
34 shall be transferred to the county jail.

35 Sec. 8. A regional holding facility agreement must include terms  
36 concerning the standards that will apply to the establishment and  
37 operation of a regional holding facility.

38 Sec. 9. (a) The Indiana criminal justice institute shall identify  
39 any federal, state, or local grants that can be used to assist in the  
40 funding and operation of regional holding facilities.

41 (b) To obtain necessary funding for the establishment and  
42 operation of regional holding facilities, or to provide such services



1 through contractual agreements with public and private agencies,  
2 the commissioner may accept gifts, grants, and subsidies from any  
3 lawful source and apply for and accept federal funds.

In this case, ownership reverts back to the governmental body upon the termination of the BOT agreement.

(3) The BOT agreement must identify which costs are to be the responsibility of the operator and which costs are to be the responsibility of the governmental body.

(4) The operator may be authorized to retain a mutually agreed





upon percentage of the revenues received in the operation and management of the public facility, or the operator may be paid an amount established by the governmental body, which shall be applied as follows:

- (A) Capital outlay costs for the public facility and public service plus interest and principal repayment for any debt incurred.
  - (B) Costs associated with the operation, management, and maintenance of the public facility.
  - (C) Payment to the governmental body for reimbursement of the costs of maintenance, law enforcement, and other services if the services are performed by the governmental body under the BOT agreement.
  - (D) An agreed upon return on investment to the operator.
- (5) The operator may pay the governmental body either a lease payment or a percentage of gross revenue per month for the operator's operation and use of the public facility.
- (6) The BOT agreement may require a performance bond and provide for the payment of contractors and subcontractors under IC 4-13.6-7, IC 5-16-5, or IC 36-1-12, whichever is applicable.
- (7) If a regional jail (as defined in IC 11-12-5.5-1) is the subject of a BOT agreement under this chapter, the operator and the governmental body may mutually agree that ownership of the regional jail will remain with the operator during the term of the BOT agreement and after termination of the BOT agreement. The governmental body shall pay costs associated with the design, construction, financing, operation, management, and maintenance of the regional jail from funds identified under IC 11-12-5.5-3.**

- (1) The location of the regional jail.
- (2) The acquisition, **design, financing**, construction, leasing, maintenance, repair, operation, termination of operations, and administration of the regional jail.
- (3) The manner in which each participating entity's proportionate share of the funding for the regional jail will be determined.
- (4) The manner in which any:
  - (A) per diem paid by the state; or
  - (B) other reimbursement paid by the state;
 for the costs of incarcerating individuals in a county jail or the costs of medical care expenses incurred for individuals in a county jail will be used by the participating entities.
- (5) Any pledge of local revenue that will be required to carry out the regional jail agreement or to pay bonds issued or leases entered into by a participating entity to carry out the regional jail agreement.
- (6) The standards that will apply to the regional jail.
- (7) The method of determining the inmate programs, activities, and services that will be provided at the regional jail.



(8) The method of resolving disputes among the participating entities concerning the regional jail agreement, if any such disputes arise.

**(b) Notwithstanding IC 5-23, if a public-private agreement (as defined in IC 5-23-2-13) is entered into to design, finance, construct, maintain, or operate a regional jail, the manner of acquiring, holding, and disposing of real property under the joint agreement may include ownership by the operator of:**

- (1) real property on which the regional jail is constructed;**
- (2) personal property of the regional jail; and**
- (3) all improvements to the regional jail during and after the termination of the public-private agreement.**

SECTION 10. IC 11-12-5.5-6 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]: **Sec. 6. A regional jail may provide any combination of:**

- (1) substance abuse treatment (as defined in IC 11-12-3.8-1.5);**
- (2) jail treatment (as described in IC 11-12-2);**
- (3) recidivism reduction programs (as described in IC 11-12-2); or**
- (4) any other program or service the participating entities determine is necessary or appropriate."**

- (5) One (1) member of the senate to be appointed by the minority leader of the senate.**
- (6) An individual appointed by the governor in consultation with the Association of Indiana Counties.**
- (7) An individual appointed by the governor with expertise in mental health and drug treatment.**
- (8) An individual appointed by the governor with experience in community corrections.**
- (9) The commissioner of the department of correction or the commissioner's designee.**
- (10) One (1) member of the Indiana Prosecuting Attorneys Council.**
- (11) One (1) member of the public defender council of Indiana.**
- (12) One (1) member of the Indiana Sheriff's Association.**
- (13) The superintendent of the state police department.**

**Sec. 4. (a) A majority of the members of the task force constitutes a quorum.**

**(b) The affirmative vote of at least a majority of the members at which a quorum is present is necessary for the task force to take**



official action other than to meet and take testimony.

(c) The task force shall meet at the call of the chair.

(d) The task force shall hold up to five (5) regional meetings.

Sec. 5. All meetings of the task force shall be open to the public in accordance with and subject to IC 5-14-1.5. All records of the task force shall be subject to the requirements of IC 5-14-3.

Sec. 6. The task force shall do the following:

(1) Conduct a statewide review of jail overcrowding to identify common reasons and possible local, regional, and statewide solutions.

(2) Study the issue of how to reduce recidivism for convicted felons in county jails by offering programs that address:

(A) mental health and drug and alcohol treatment services;

(B) educational programs; and

(C) other evidence based programs designed to reduce recidivism.

Sec. 7. The task force shall submit a report to the:

(1) governor;

(2) chief justice; and

(3) legislative council;

not later than December 1, 2019. The report submitted to the legislative council must be in an electronic format under IC 5-14-6.

Sec. 8. The chapter expires January 1, 2020."
