

HOUSE BILL No. 1104

DIGEST OF INTRODUCED BILL

Citations Affected: IC 9-18.5-5-2.

Synopsis: Disabled veteran parking placard. Provides that a person who is qualified to receive a disabled Hoosier veteran plate and has been issued a permanent parking placard may not be charged a fee for parking in a metered space or assessed a penalty for parking in a metered space for longer than the time permitted.

Effective: July 1, 2019.

HOUSE BILL No. 1104

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 9-18.5-5-2, AS ADDED BY P.L.198-2016,
2 SECTION 327, IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2019]: Sec. 2. (a) An individual qualifying
4 under section 1 of this chapter **or issued a permanent parking**
5 **placard under IC 9-18.5-8-4(a)(3)** may not be:
6 (1) charged a fee for parking in a metered space; or
7 (2) assessed a penalty for parking in a metered space for longer
8 than the time permitted.
9 (b) This section does not authorize parking of a vehicle in a parking
10 space during a time when parking in the space is prohibited if the
11 prohibition is:
12 (1) posted; and
13 (2) authorized:
14 (A) by ordinances in cities and towns; or
15 (B) by order of the Indiana department of transportation.
16 (c) **The following are not entitled to the parking privileges**
17 **authorized by this section:**



- 1 (1) An individual other than the owner of the vehicle displaying
- 2 a disabled Hoosier veteran license plate authorized by this
- 3 chapter. ~~is not entitled to the parking privileges authorized by this~~

- 5 **(2) Except when the individual is transporting an individual**
- 6 **qualified under IC 9-18.5-8-4(a)(3), an individual other than**

- 9 **an individual qualified under IC 9-18.5-8-4(a)(3).**
