DIGEST OF INTRODUCED BILL

Citations Affected: IC 36-7-41.

Synopsis: Professional sports development commission. Establishes the northwest Indiana professional sports development commission. Authorizes the commission to study various plans and recommendations that are proposed with respect to attracting a professional sports franchise to northwest Indiana. Authorizes the commission to prepare a comprehensive master plan for building the facilities and other infrastructure necessary for attracting and developing one or more professional sports franchises in northwest Indiana. Creates the professional sports development fund.

Be it enacted by the General Assembly of the State of Indiana:

15	(6) The mayor of Portage.

17	(8) Four (4) members appointed under subsection (b).
18	(9) Four (4) members appointed under subsection (c).
19	(10) One (1) member appointed by the executive director of

21	(11) One (1) member appointed by the governor to represent

5	commission shall be filled by the appointing authority.

7	employee is entitled to reimbursement for traveling expenses as
8	provided in the rules adopted under IC 4-13-1-4 and other
9	expenses actually incurred in connection with the member's duties
10	as provided in the state policies and procedures established by the
11	Indiana department of administration and approved by the budget
12	agency.
13	(b) Each member of the commission who is not a state employee
14	is entitled to the minimum salary per diem provided by
15	IC 4-10-11-2.1(b). The member is also entitled to reimbursement
16	for traveling expenses as provided in the rules adopted under
17	IC 4-13-1-4 and other expenses actually incurred in connection
18	with the member's duties as provided in the state policies and
19	procedures established by the Indiana department of
20	administration and approved by the budget agency.
21	Sec. 8. (a) A quorum of the commission must be present to
22	conduct the commission's business. A quorum consists of ten (10)
23	members of the commission.
24	(b) The affirmative votes of ten (10) members of the commission
25	are required for the commission to take action on any measure.
26	Sec. 9. (a) The commission shall hold its initial meeting before
27	September 1, 2024, at the call of the member appointed under
28	section 3(a)(10) of this chapter.
29	(b) The commission shall elect the following officers from
30	among the members of the commission:
31	(1) A chairperson.
32	(2) A vice chairperson.
33	(3) A treasurer.
34	(c) The term of each officer elected under subsection (b):
35	(1) is one (1) year; and
36	(2) ends on June 30.
37	(d) An officer may be reappointed.

39	(1) shall fix the time for regular meetings; and

1	(6) Enter into agreements or contracts regarding the
2	acceptance or use of these grants and appropriations for the
3	purpose of carrying out the commission's activities under this

5	(7) Acquire and dispose of real or personal property by grant,
6	gift, purchase, lease, devise, or otherwise.
7	(8) Hold, use, improve, maintain, operate, own, manage, or
8	lease as lessor or lessee:
9	(A) real or personal property; or
10	(B) any interest in real or personal property.
11	(9) Employ an executive director and other individuals who
12	are necessary to carry out the commission's duties.
13	(10) Contract for staff services with qualified agencies or
14	individuals.
15	Sec. 13. (a) After approval of the budget by the commission,
16	money may be expended only as budgeted, unless a majority vote
17	of the commission authorizes other expenditures.
18	(b) The treasurer of the commission is responsible for the
19	safekeeping and deposit of money the commission receives under
20	this chapter. The state board of accounts shall:
21	(1) prescribe the methods and forms for keeping; and
22	(2) periodically audit;
23	the accounts, records, and books of the commission.
24	(c) The treasurer of the commission may receive, disburse, and
25	handle money belonging to the commission, subject to the
26	following:
27	(1) Applicable statutes.
28	(2) Procedures established by the commission.
29	Sec. 14. (a) The professional sports development fund is created.
30	The commission may make expenditures from the fund only to
31	accomplish the purposes of this chapter.
32	(b) The fund consists of the following:
33	(1) Appropriations made to the fund by the general assembly.
34	(2) Grants, gifts, and donations intended for deposit in the
35	fund.
36	(3) Interest that accrues from money in the fund.
37	(4) Money from any other source deposited in the fund.
38	(c) The commission shall do the following:
39	(1) Hold the fund in the name of the commission.
40	(2) Administer the fund.
41	(3) Make all expenditures from the fund.
42	(d) The money in the fund at the end of a state fiscal year



1 remains in the fund and does not revert to any other fund.
