# HOUSE BILL No. 1201

### DIGEST OF INTRODUCED BILL

### Citations Affected: IC 9-32-11-20.

**Synopsis:** Vehicle right of use subscription programs. Provides that a manufacturer or distributor may not offer, directly or indirectly, a vehicle right of use subscription program to the general public in Indiana or otherwise engage in a vehicle right of use subscription program in the state. Provides that a manufacturer or distributor may only offer a vehicle right of use subscription program to the general public if done through, or in partnership with, a franchised motor vehicle dealer licensed under this article that is of the same line make affiliated with the manufacturer or distributor.

Effective: April 1, 2020.

# HOUSE BILL No. 1201

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 9-32-11-20, AS AMENDED BY P.L.245-2019,
2	SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	APRIL 1, 2020]: Sec. 20. (a) This section does not apply to:
4	(1) a manufacturer of a trailer or semitrailer; or
5	(2) a manufacturer that produces fewer than one thousand $(1,000)$
6	units per year.
7	(b) Except as provided in subsection (c), a manufacturer or
8	distributor may not engage in sales directly or indirectly to the general
9	public in Indiana by contract, solicitation of sale, or any other offer
10	or attempt to contract or sell regardless of form.
11	(c) A manufacturer or distributor may engage in sales directly to the
12	general public in Indiana only if:
13	(1) the manufacturer or distributor was granted an initial license
14	to sell new motor vehicles before July 1, 2015; and
15	(2) the manufacturer or distributor establishes at least one (1)
16	physical location in Indiana that is a warranty repair service
17	center before January 1, 2018.



(d) A manufacturer or distributor described in subsection (c) must stop engaging in sales directly to the general public in Indiana if the manufacturer or distributor sells, transfers, or conveys a majority interest in the manufacturer or distributor to another person that is required to be licensed under this chapter.

6 (e) For purposes of this subsection and subsection (f), "vehicle 7 right of use subscription program" means a subscription service that, 8 for a recurring fee and for a limited period of time, allows a 9 participating person exclusive use of a motor vehicle owned by an 10 entity that controls or contracts with the subscription service. program 11 participating person or entity ("subscription service"). The term 12 does not include leases, short term motor vehicle rentals, or services 13 that allow short term sharing of a motor vehicle. Subscription programs 14 are prohibited in Indiana. This subsection expires on May 1, 2020. 15 Except as provided in subsection (f), a manufacturer or distributor 16 may not offer, directly or indirectly, a vehicle right of use 17 subscription program to the general public in Indiana or otherwise 18 engage in a vehicle right of use subscription program in the state. 19 (f) A manufacturer or distributor may only offer a vehicle right 20

of use subscription program to the general public if done through,
or in partnership with, a franchised motor vehicle dealer licensed
under this article that is of the same line make affiliated with the
manufacturer or distributor.

24 SECTION 2. An emergency is declared for this act.
