

HOUSE BILL No. 1336

DIGEST OF HB 1336 (Updated January 22, 2020 7:11 pm - DI 77)

Citations Affected: IC 25-1.

Synopsis: Telemedicine. Specifies certain activities that are considered to be health care services for purposes of the telemedicine laws. Amends the definition of "telemedicine". Requires that the medical records under telemedicine must be created and maintained under the same standards of appropriate practice for medical records for patients in an in-person setting.

Effective: July 1, 2020.

HOUSE BILL No. 1336

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 25-1-9.5-2.5 IS ADDED TO THE INDIANA
CODE AS A NEW SECTION TO READ AS FOLLOWS
[EFFECTIVE JULY 1, 2020]: Sec. 2.5. As used in this chapter
"health care services" includes the following:
(1) Assessment, diagnosis, evaluation, consultation, treatment
and monitoring of a patient.
(2) Transfer of medical data.
(3) Patient health related education.
(4) Public health services and health administration.
SECTION 2. IC 25-1-9.5-6, AS ADDED BY P.L.78-2016
SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
JULY 1, 2020]: Sec. 6. (a) As used in this chapter, "telemedicine
means the delivery of health care services using interactive electronic
communications and information technology, including:
(1) secure videoconferencing;
(2) interactive audio-using store and forward technology; or
(3) remote patient monitoring technology;

11	SECTION 3. IC 25-1-9.5-7, AS AMENDED BY P.L.129-2018,
12	SECTION 26, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
13	JULY 1, 2020]: Sec. 7. (a) A prescriber who provides health care
14	services through telemedicine shall be held to the same standards of
15	appropriate practice as those standards for health care services
16	provided at an in-person setting.
17	(b) A prescriber may not use telemedicine, including issuing a
18	prescription, for an individual who is located in Indiana unless a
19	provider-patient relationship between the prescriber and the individual
20	has been established. A prescriber who uses telemedicine shall, if such
21	action would otherwise be required in the provision of the same health
22	care services in a manner other than telemedicine, ensure that a proper
23	provider-patient relationship is established. The provider-patient
24	relationship by a prescriber who uses telemedicine must at a minimum
25	include the following:
26	(1) Obtain the patient's name and contact information and:
27	(A) a verbal statement or other data from the patient
28	identifying the patient's location; and
29	(B) to the extent reasonably possible, the identity of the
30	requesting patient.
31	(2) Disclose the prescriber's name and disclose whether the
32	prescriber is a physician, physician assistant, advanced practice
33	registered nurse, optometrist, or podiatrist.
34	(3) Obtain informed consent from the patient.
35	(4) Obtain the patient's medical history and other information
36	necessary to establish a diagnosis.
37	(5) Discuss with the patient the:
38	(A) diagnosis;
39	(B) evidence for the diagnosis; and
40	(C) risks and benefits of various treatment options, including
41	when it is advisable to seek in-person care.
42	(6) Create and maintain a medical record for the patient and,



1	subject to the consent of the patient, notify the patient's primary
2	care provider of any prescriptions the prescriber has issued for the
3	patient if the primary care provider's contact information is
4	provided by the patient. The requirements in this subdivision do
5	not apply when any of the following are met:
6	(A) The prescriber is using an electronic health record system
7	that the patient's primary care provider is authorized to access
8	(B) The prescriber has established an ongoing provider-patien
9	relationship with the patient by providing care to the patient a
10	least two (2) consecutive times through the use of telemedicine
11	services. If the conditions of this clause are met, the prescribe
12	shall maintain a medical record for the patient and shall notify
13	the patient's primary care provider of any issued prescriptions
14	(7) Issue proper instructions for appropriate follow-up care.
15	(8) Provide a telemedicine visit summary to the patient, including
16	information that indicates any prescription that is being
17	prescribed.
18	(c) The medical records under subsection (b)(6) must be created
19	and maintained under the same standards of appropriate practice
20	for medical records for patients in an in-person setting.
