Synopsis: Project Lifesaver program requirement for counties. Requires each county to establish and maintain a Project Lifesaver program. Tasks the division of disability and rehabilitative services with ensuring compliance, and requires the division to report to the general assembly.

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

10	(3) caregivers;
11	with a program designed to protect and locate an individual with
12	a cognitive disorder who is prone to wandering behavior.
13	Sec. 2. Not later than January 1, 2025, a county shall establish
14	and maintain its own Project Lifesaver program.
15	Sec. 3. The county fiscal body of a county shall appropriate and
16	approve the money necessary for the county to comply with this
17	chapter.

Sec. 4. (a) The division of disability and rehabilitative services shall ensure that a county complies with this chapter.

- (b) The division of disability and rehabilitative services shall report, in an electronic format under IC 5-14-6, county compliance to the general assembly not later than March 1, 2025.
- (c) The division of disability and rehabilitative services may adopt rules under IC 4-22-2 to carry out this chapter.
