DIGEST OF HB 1471 (Updated February 9, 2015 12:41 pm - DI 109)

Citations Affected: IC 14-19.

Synopsis: Recreational trails guidelines. Requires the division of outdoor recreation of the department of natural resources to develop recreational trails guidelines to address the following issues as they relate to recreational trails: (1) Clear statement of ownership and management of each trail. (2) Right-of-way inconsistencies. (3) Fence line issues. (4) Drainage issues, including tile drains. (5) Tree and brush control. (6) Weed and mowing issues. (7) Law enforcement jurisdiction issues. (8) Signage issues. (9) Conflict resolution procedures. (10) Appeal procedures.

Effective: July 1, 2015.

HOUSE BILL No. 1471

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 14-19-1-1.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2015]: **Sec. 1.5. (a) Before October 1, 2015, the department shall,**
4 **through the division of outdoor recreation, develop guidelines**
5 **concerning recreational trails and amend the guidelines as**
6 **necessary or advisable thereafter. The guidelines must address at**
7 **least the following issues:**
8 (1) **Clear statement of ownership and management of each**
9 **trail.**
10 (2) **Right-of-way inconsistencies.**
11 (3) **The division of responsibility for maintenance of fences,**
12 **for drainage, and for maintenance of drainage or drain tiles.**
13 (4) **Tree, weed, and brush removal between responsible**
14 **parties and landowners adjacent to recreational trails.**
15 (5) **Mowing responsibility.**

- 2 **(7) Signage.**
- 3 **(8) Conflict resolution procedures.**
- 4 **(9) Appeal procedures.**
- 5 **(b) In developing the recreational trail guidelines described in**
- 6 **subsection (a), the division shall consult with various groups,**
- 7 **organizations, and agencies that will be impacted by the guidelines.**
- 8 **(c) The department may adopt guidelines, without complying**
- 9 **with IC 4-22-2, to implement this section.**

Page 2, line 7, delete "policy." and insert "**guidelines.**".

Page 2, line 8, delete "shall adopt rules under IC 4-22-2" and insert "**may adopt guidelines, without complying with IC 4-22-2,**".
