

HOUSE BILL No. 1108

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-28.

Synopsis: Dyslexia. Defines "dyslexia" for purposes of teacher licensing. Requires an individual who seeks to receive an initial practitioner's license as an elementary school teacher to demonstrate proficiency in the recognition of specific learning disabilities related to reading, including dyslexia.

Effective: July 1, 2015.

HOUSE BILL No. 1108



A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-28-1-6.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY**
3 **1, 2015]: Sec. 6.5. "Dyslexia" means a specific learning disability**
4 **that:**
5 **(1) is neurological in origin and characterized by:**
6 **(A) difficulties with accurate or fluent word recognition;**
7 **and**
8 **(B) poor spelling and decoding abilities;**
9 **(2) typically results from a deficit in the phonological**
10 **component of language that is often unexpected in relation to**
11 **other cognitive abilities and the provision of effective**
12 **classroom instruction; and**
13 **(3) may include problems in reading comprehension and**
14 **reduced reading experience that can impede the growth of**
15 **vocabulary and background knowledge.**



1 SECTION 2. IC 20-28-5-12, AS AMENDED BY P.L.6-2012,
2 SECTION 136, IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2015]: Sec. 12. (a) Subsection (b) does not
4 apply to an individual who held an Indiana limited, reciprocal, or
5 standard teaching license on June 30, 1985.

6 (b) The department may not grant an initial practitioner license to
7 an individual unless the individual has demonstrated proficiency in the
8 following areas on a written examination or through other procedures
9 prescribed by the department:

- 10 (1) Basic reading, writing, and mathematics.
11 (2) Pedagogy.
12 (3) Knowledge of the areas in which the individual is required to
13 have a license to teach.
14 (4) If the individual is seeking to be licensed as an elementary
15 school teacher, comprehensive scientifically based reading
16 instruction skills, including:
17 (A) phonemic awareness;
18 (B) phonics instruction;
19 (C) fluency;
20 (D) vocabulary; and
21 (E) comprehension.

22 **(5) If the individual is seeking to be licensed as an elementary**
23 **school teacher, the recognition of specific learning disabilities**
24 **related to reading, including dyslexia.**

25 (c) An individual's license examination score may not be disclosed
26 by the department without the individual's consent unless specifically
27 required by state or federal statute or court order.

28 (d) The state board shall adopt rules under IC 4-22-2 to do the
29 following:

- 30 (1) Adopt, validate, and implement the examination or other
31 procedures required by subsection (b).
32 (2) Establish examination scores indicating proficiency.
33 (3) Otherwise carry out the purposes of this section.

34 (e) The state board shall adopt rules under IC 4-22-2 establishing
35 the conditions under which the requirements of this section may be
36 waived for an individual holding a valid teacher's license issued by
37 another state.
