

HOUSE BILL No. 1108

DIGEST OF HB 1108 (Updated January 22, 2015 9:54 am - DI 116)

Citations Affected: IC 20-18; IC 20-20; IC 20-28.

Synopsis: Dyslexia. Defines "dyslexia" for purposes of teacher licensing. Requires an individual who seeks to receive an initial practitioner's license as an elementary school teacher to demonstrate proficiency in the recognition of specific learning disabilities related to reading, including dyslexia. Provides that if an education service center offers inservice training or other teacher training programs, the education service center may offer courses for teachers on dyslexia screening and appropriate interventions.

Effective: July 1, 2015.

HOUSE BILL No. 1108

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

"SECTION 2. IC 20-20-1-13 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 13. If an education service center offers inservice training or other teacher training programs, the education service center may offer courses for teachers on dyslexia screening and appropriate interventions, including courses relating to the Orton-Gillingham approach to reading instruction."

Renumber all SECTIONS consecutively.
