1           A CONCURRENT RESOLUTION urging INDOT to honor  
2 Deputy David Morgan of the Madison County Sheriff's  
3 Department by renaming a portion of State Road 37 the Deputy  
4 David Morgan Memorial Highway.

5           *Whereas, Deputy Morgan was a Madison County Sheriff's*  
6 *Department deputy for 33 years after having served in the U.S.*  
7 *Army;*

8           *Whereas, Deputy Morgan spent many of his years on the*  
9 *midnight shift patrolling the northwest quadrant of Madison*  
10 *County on State Road 37;*

11           *Whereas, It is estimated that Deputy Morgan issued more*  
12 *than 10,000 citations on this stretch of highway throughout his*  
13 *career;*

14           *Whereas, Deputy Morgan made a difference in countless lives*  
15 *because of his diligent traffic enforcement;*

16           *Whereas, Throughout his time with the Madison County*  
17 *Sheriff's Department, Deputy Morgan held positions of patrol*  
18 *deputy, SWAT team member, and firearms instructor;*

19           *Whereas, He was an avid supporter of the Madison County*  
20 *4-H, helping his children and later others raise pigs for the*  
21 *annual fair;*

22           *Whereas, Deputy Morgan was blessed to have an amazing*  
23 *family, which included his son, Scott; daughters Jennifer,*  
24 *Shelby, and Cheyenne; sister, Kathy; and parents, Richard and*

2 *Whereas, Deputy Morgan passed away on September 10,*  
3 *2017; and*

4 *Whereas, It is fitting that in honoring Deputy Morgan's*  
5 *service, the portion of State Road 37 patrolled by Deputy*  
6 *Morgan should be designated as the Deputy David Morgan*  
7 *Memorial Highway: Therefore,*

8 *Be it resolved by the House of Representatives*  
9 *of the General Assembly of the State of Indiana,*  
10 *the Senate concurring:*

11 SECTION 1. That the Indiana General Assembly urges  
12 INDOT to honor Deputy David Morgan for his service to the  
13 Madison County Sheriff's Department by renaming the  
14 northwest portion of State Road 37 passing through Madison  
15 County as the Deputy David Morgan Memorial Highway.

16 SECTION 2. That the Principal Clerk of the House of  
17 Representatives shall transmit a copy of this resolution to Sue  
18 Morgan, Kathy Morgan, Scott Morgan, Jennifer Morgan,  
19 Shelby Morgan, Cheyenne Morgan, Bob Alderman, the  
20 commissioner of INDOT, and Detective Brian Holtzleiter.
