1 A CONCURRENT RESOLUTION honoring the inductees
2 of the Indiana Military Veterans Hall of Fame.

3 *Whereas, The Indiana Military Veterans Hall of Fame*
4 *(IMVHOF) was founded in 2013;*

5 *Whereas, The mission of the IMVHOF is to publicly*
6 *"emphasize the honor brought to our state and nation by the*
7 *sacrifice of Indiana military veterans and their families";*

8 *Whereas, The first Hoosiers were inducted into the IMVHOF*
9 *on November 7, 2014;*

10 *Whereas, The 2019 inductees are Irvin Alexander, Dennis A.*
11 *Beals, Donald E. Bolner, Jay A. Collars, Charles H. DeBow,*
12 *Jr., David W. Eberly, Roland W. Henry, Maurice W. Kendall,*
13 *Charles W. Lewis, Fred S. Lindsey, Henry C. Marshall, Ivan*
14 *Moreman, Forrest E. Myers, Frank H. Ono, Conrad A. Sipple,*
15 *and Gary C. Steinhardt;*

16 *Whereas, Nominations came from all over the state and*
17 *represented military veterans from World War I through the*
18 *current engagements in the Middle East and elsewhere;*

19 *Whereas, Each inductee receives a medallion representing the*
20 *IMVHOF and its relationship to Indiana;*

21 *Whereas, The medallion's front side depicts Indiana and the*
22 *name of the organization while the back side displays the state*
23 *flag and the engraved name of the inductee encircled by the*
24 *names of the five branches of the United States armed forces;*



1 *Whereas, Throughout the history of our great nation,*
2 *hundreds of thousands of men and women have served their*
3 *country with honor and pride in time of war and peace; and*

4 *Whereas, The Indiana Military Veterans Hall of Fame honors*
5 *these brave Hoosier veterans for their service and shares their*
6 *stories of sacrifice with the people of our state: Therefore,*

7 *Be it resolved by the House of Representatives*
8 *of the General Assembly of the State of Indiana,*
9 *the Senate concurring:*

10 SECTION 1. That the Indiana General Assembly recognizes
11 the inductees into the Indiana Military Veterans Hall of Fame
12 for their great bravery and dedication to duty. Without brave
13 men and women like these, our state and nation could not exist.

14 SECTION 2. That the Principal Clerk of the House of
15 Representatives shall transmit a copy of this resolution to the
16 Board of Directors of the Indiana Military Veterans Hall of
17 Fame.
