6 *Whereas, Deputy Sarah Irene Haylett-Jones displayed*
7 *passion for public safety, law enforcement, and a need to help*
8 *others throughout her life;*

9 *Whereas, Deputy Haylett-Jones was born on April 2, 1981, to*
10 *Wayne and Kimalee Haylett;*

11 *Whereas, In her youth, she was active in the 4-H, Big*
12 *Brothers and Big Sisters, and had become a captain in the*
13 *Michigan State Police Explorers program;*

14 *Whereas, Deputy Haylett-Jones was a veteran of the United*
15 *States Air Force, serving from 2001 to 2006 and becoming the*
16 *president of the Airman's Association;*

17 *Whereas, Deputy Haylett-Jones continued her life in public*
18 *service, earning a position with the Montgomery, Alabama,*
19 *Police Department and serving for one and one half years*
20 *before moving to Indiana to join the Monroe County Sheriff's*
21 *Office;*

22 *Whereas, Deputy Haylett-Jones suffered injuries that she*
23 *sustained on October 17, 2008, after being struck by a vehicle*
24 *while directing traffic around an accident at the intersection of*
25 *West Airport Road and State Road 45 outside of Bloomington,*

2 *Whereas, At the age of 27, Deputy Haylett-Jones passed away*
3 *on October 19, 2008, and was survived by her parents, Wayne*
4 *and Kimalee; husband, Chris; in-laws, Steven and Connie;*
5 *two brothers, Matthew and Jess; and her grandmother, Vivian;*

6 *Whereas, It is fitting that the Indiana General Assembly*
7 *recognize Deputy Haylett-Jones's service to Indiana, as well as*
8 *her lifetime spent in the service of others; and*

9 *Whereas, The Indiana General Assembly urges the Indiana*
10 *Department of Transportation to rename a portion of State*
11 *Road 45 the "Sarah Irene Haylett-Jones Memorial Highway"*
12 *in memory of Deputy Haylett-Jones's service to Monroe County*
13 *and Indiana: Therefore,*

14 *Be it resolved by the House of Representatives*
15 *of the General Assembly of the State of Indiana,*
16 *the Senate concurring:*

17 SECTION 1. That the Indiana General Assembly urges the
18 Indiana Department of Transportation to rename a portion of
19 State Road 45 near the intersection with West Airport Road in
20 Monroe County the "Sarah Irene Haylett-Jones Memorial
21 Highway" to honor Deputy Haylett-Jones and remember her
22 devotion to public safety and service to others.

23 SECTION 2. That the Principal Clerk of the House of
24 Representatives shall transmit copies of this resolution to the
25 family of Deputy Haylett-Jones and the Commissioner of the
26 Indiana Department of Transportation.
