5	Whereas, Deputy Sarah Irene Haylett-Jones displayed
6	passion for public safety, law enforcement, and a need to help
7	others throughout her life;
8	Whereas, Deputy Haylett-Jones was born on April 2, 1981, to
9	Wayne and Kimalee Haylett;
10	Whereas, In her youth, she was active in the 4-H and Big
11	Brothers and Big Sisters, and had become a captain in the
12	Michigan State Police Explorers program;
13	Whereas, Deputy Haylett-Jones was a veteran of the United
14	States Air Force, serving from 2001 to 2006 and becoming the
15	president of the Airman's Association;
16	Whereas, Deputy Haylett-Jones continued her life in public
17	service, earning a position with the Montgomery, Alabama,
18	Police Department and serving for one and one half years
19	before moving to Indiana to join the Monroe County Sheriff's
20	Office;
21	Whereas, Deputy Haylett-Jones suffered injuries that she
22	sustained on October 17, 2008, after being struck by a vehicle
23	while directing traffic around an accident at the intersection of
24	West Airport Road and State Road 45 outside of Bloomington,
25	Indiana;



1	Whereas, At the age of 27, Deputy Haylett-Jones passed away
2	on October 19, 2008, and was survived by her parents, Wayne
3	and Kimalee; husband, Chris; in-laws, Steven and Connie; two
4	brothers, Matthew and Jess; and her grandmother, Vivian; and
5	Whereas, It is fitting that the Indiana General Assembly
6	recognize Deputy Haylett-Jones' service to Indiana, as well as
7	her lifetime spent in the service of others: Therefore,
8	Be it resolved by the House of Representatives
9	of the General Assembly of the State of Indiana,
10	the Senate concurring:
11	SECTION 1. The Indiana General Assembly urges the
12	Indiana Department of Transportation to rename the State Road
13	45 and 2nd Street bridge over I-69 the "Sarah Irene
14	Haylett-Jones Memorial Bridge" in memory of Deputy
15	Haylett-Jones' service to Monroe County and Indiana.
16	SECTION 2. That the Principal Clerk of the House of
17	Representatives shall transmit copies of this resolution to the
18	family of Deputy Haylett-Jones and the Commissioner of the
19	Indiana Department of Transportation.
