1           A CONCURRENT RESOLUTION recognizing Honda  
2 Manufacturing of Indiana for its contributions to the  
3 community.

4           *Whereas, Honda Manufacturing of Indiana produced its*  
5 *two-millionth car in Greensburg since manufacturing began in*  
6 *2008;*

7           *Whereas, Honda-Greensburg produced the milestone, a*  
8 *Crystal Black Pearl CR-V, on May 31, 2019;*

9           *Whereas, Honda-Greensburg is a 2.4 million square foot*  
10 *facility employing more than 2,500 employees, with the*  
11 *capacity to build 250,000 vehicles each year;*

12           *Whereas, Honda Manufacturing of Indiana has been a*  
13 *proactive member of the Hoosier community with programs like*  
14 *Hands on Honda, an employee-volunteerism program, and by*  
15 *offering in-kind donations, food drives, blood drives, and*  
16 *financial support for eligible nonprofit organizations;*

17           *Whereas, Honda Manufacturing of Indiana became a*  
18 *founding partner of the Conexus Indiana program INvets,*  
19 *which provides meaningful job training and hiring*  
20 *opportunities for Indiana's military service members;*

21           *Whereas, Honda has announced a four million dollar*  
22 *expansion to add 54 jobs to plant operations and expand the*  
23 *Honda-Greensburg portfolio to include the CR-V Hybrid;*

24           *Whereas, Honda-Greensburg will produce the Honda Civic,*



1 *Insight, CR-V, and CR-V Hybrid upon completion of its*  
2 *expansion; and*

3 *Whereas, The Indiana General Assembly recognizes the*  
4 *positive impact of Honda Manufacturing of Indiana and wishes*  
5 *the company continued success for years to come: Therefore,*

6 *Be it resolved by the House of Representatives*  
7 *of the General Assembly of the State of Indiana,*  
8 *the Senate concurring:*
