DIGEST OF SB 2 (Updated January 28, 2020 9:41 am - DI 135)

Citations Affected: Noncode.

Synopsis: School accountability. Provides that a school's or school corporation's category or designation of school or school corporation performance assigned by the state board of education for the 2018-2019 school year may not be lower than the school's or school corporation's category or designation of school or school corporation performance for the 2017-2018 school year. Provides that a school's or school corporation's category or designation of school or school corporation performance assigned by the state board of education for the 2019-2020 school year is the higher of the school's or school corporation performance for the 2017-2018 school year and the 2018-2019 school year.

Provides that consequences for school improvement do not apply for the 2018-2019 or 2019-2020 school years. Provides that ILEARN program test scores or a school's category or designation of school improvement for the 2018-2019 or 2019-2020 school year may not be used by a school corporation as part of an annual performance evaluation of a particular certificated employee unless the use of the ILEARN program test scores or a school's category or designation of school improvement would improve the particular certificated employee's annual performance rating.

ENGROSSED SENATE BILL No. 2

A BILL FOR AN ACT concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. [EFFECTIVE JULY 1, 2018 (RETROACTIVE)] (a)
2 **The definitions in IC 20 apply throughout this SECTION.**
3 **(b) Notwithstanding IC 20-31-8 and 511 IAC 6.2-10, a school's**
4 **or school corporation's category or designation of school or school**
5 **corporation performance assigned by the state board under**
6 **IC 20-31-8-4 for the 2018-2019 school year shall be calculated in**
7 **the manner provided in 511 IAC 6.2-10, with the exception that a**
8 **school's or school corporation's category or designation of school**
9 **or school corporation performance for the 2018-2019 school year**
10 **may not be lower than the school's or school corporation's**
11 **category or designation of school or school corporation**
12 **performance for the 2017-2018 school year.**
13 **(c) Notwithstanding IC 20-31-8 and 511 IAC 6.2-10, a school's**

16 **IC 20-31-8-4 for the 2019-2020 school year shall be calculated in**

16 category or designation of school performance under subsections
17 (b) and (c). However, a school may petition the state board, and the
18 state board shall grant the school's petition to use the grade
19 assigned to the school under subsection (b) or (c) for purposes of
20 applying IC 20-31-9.

21 (e) Notwithstanding IC 20-51-4-9, and except as otherwise
22 provided in this subsection, an eligible school's (as defined in
23 IC 20-51-1-4.7) category or designation of school performance
24 under subsection (b) or (c) may not be used in the determination of
25 consequences under IC 20-51-4-9 if the eligible school is placed in
26 either of the two (2) lowest categories or designations of school
27 performance under subsection (b) or (c). The eligible school's
28 category or designation of school performance for the 2020-2021
29 school year shall be considered the category or designation for the
30 school year immediately following the 2017-2018 school year for
31 purposes of applying consequences under IC 20-51-4-9 for an
32 eligible school that has been placed in the two (2) lowest categories
33 or designations of school performance under subsections (b) and
34 (c). However, an eligible school may petition the state board, and
35 the state board shall grant the eligible school's petition to use the
36 eligible school's category or designation of school performance
37 assigned under subsection (b) or (c) for purposes of applying
38 IC 20-51-4-9.

39 (f) Notwithstanding IC 20-24-2.2-2, a charter school's category
40 or designation of school performance for the 2020-2021 school year
41 shall be considered the category or designation for the school year
42 immediately following the 2017-2018 school year for purposes of

9 SECTION 2. [EFFECTIVE JULY 1, 2018 (RETROACTIVE)] (a)
10 The definitions in IC 20 apply throughout this SECTION.

11 (b) Notwithstanding IC 20-28-11.5-4 or 511 IAC 10-6-4,
12 ILEARN program test scores or a school's category or designation
13 of school improvement under IC 20-31-8 for the 2018-2019 or
14 2019-2020 school year, based on Indiana's Learning Evaluation
15 Assessment Readiness Network (ILEARN) program test under
16 IC 20-32-5.1 taken in the spring of 2019 and 2020, may not be used
17 by a school corporation as part of an annual performance
18 evaluation of a particular certificated employee under a
19 performance plan developed under IC 20-28-11.5-4 unless the use
20 of the ILEARN program test scores or a school's category or
21 designation of school improvement under IC 20-31-8 for the
22 2018-2019 or 2019-2020 school year would improve the particular
23 certificated employee's annual performance rating. If ILEARN
24 program test scores or a school's category or designation of school
25 improvement are not used in a particular certificated employee's
26 annual performance evaluation, the weight of all other measures
27 used in the certificated employee's annual performance evaluation
28 must be proportionately increased to replace measures based on
29 the ILEARN program test or the school's category or designation
30 of school improvement.

31 (c) This SECTION expires July 1, 2023.

32 SECTION 3. An emergency is declared for this act.
