SENATE BILL No. 3

DIGEST OF SB 3 (Updated February 7, 2019 9:26 am - DI 125)

Citations Affected: IC 10-11.

Synopsis: Internet crimes against children fund. Establishes the Internet crimes against children fund (fund). Requires the state police department (department) to administer the fund and use money in the fund to: (1) pay for costs incurred by the department for training and purchasing equipment for the investigation of offenses that involve the use of the Internet in which a child is the alleged victim; and (2) award grants to county, city, and town law enforcement agencies that agree to use the money to investigate Internet crimes against children in accordance with United States Department of Justice Internet Crimes Against Children Operational and Investigative Standards.

Effective: July 1, 2019.

A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 10-11-10 IS ADDED TO THE INDIANA CODE

5	Sec. 1. As used in this chapter, "fund" refers to the Internet

8	Sec. 2. (a) The Internet crimes against children fund is
9	established.
10	(b) The fund consists of appropriations from the general

12	(c) The fund may be used only for the purposes described in
13	sections 3 and 4 of this chapter.
14	(d) The fund shall be administered by the department.
15	(e) The expenses of administering the fund shall be paid from

17	Sec. 3. The department shall use money in the fund to pay for
