SENATE BILL No. 3

DIGEST OF SB 3 (Updated February 7, 2019 9:26 am - DI 125)

Citations Affected: IC 10-11.

Synopsis: Internet crimes against children fund. Establishes the Internet crimes against children fund (fund). Requires the state police department (department) to administer the fund and use money in the fund to: (1) pay for costs incurred by the department for training and purchasing equipment for the investigation of offenses that involve the use of the Internet in which a child is the alleged victim; and (2) award grants to county, city, and town law enforcement agencies that agree to use the money to investigate Internet crimes against children in accordance with United States Department of Justice Internet Crimes Against Children Operational and Investigative Standards.

Effective: July 1, 2019.

SENATE BILL No. 3

A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 10-11-10 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2019]:
4 **Chapter 10. Internet Crimes Against Children Fund**
5 **Sec. 1. As used in this chapter, "fund" refers to the Internet**
6 **crimes against children fund established by section 2 of this**
7 **chapter.**
8 **Sec. 2. (a) The Internet crimes against children fund is**
9 **established.**
10 **(b) The fund consists of appropriations from the general**
11 **assembly.**
12 **(c) The fund may be used only for the purposes described in**
13 **sections 3 and 4 of this chapter.**
14 **(d) The fund shall be administered by the department.**
15 **(e) The expenses of administering the fund shall be paid from**
16 **money in the fund.**
17 **Sec. 3. The department shall use money in the fund to pay for**

1 costs incurred by the department for training and purchasing
2 equipment for the investigation of offenses:

- 3 (1) that involve the use of the Internet; and
4 (2) in which a child is the alleged victim.

5 Sec. 4. (a) The department shall use not more than fifty percent
6 (50%) of the money deposited in the fund during a state fiscal year
7 to award grants to county, city, and town law enforcement agencies
8 that agree to use the money to investigate Internet crimes against
9 children in accordance with United States Department of Justice
10 Internet Crimes Against Children Operational and Investigative
11 Standards.

12 (b) The department shall establish:

- 13 (1) the amounts of grants awarded under this section; and
14 (2) criteria used to award grants under this section, which
15 may include any of the following:

16 (A) The geographic location and population of the
17 jurisdiction of a law enforcement agency.

18 (B) The number of reports of Internet crimes against
19 children within the jurisdiction of a law enforcement
20 agency.

21 (C) The past and current participation of a law
22 enforcement agency in the department's Internet crimes
23 against children task force.

24 (c) A county, city, or town law enforcement agency that wishes
25 to receive a grant from the fund under this section must file a
26 written application for the grant:

- 27 (1) on a form; and
28 (2) in the manner;

29 prescribed by the department.
