

SENATE BILL No. 24

DIGEST OF INTRODUCED BILL

Citations Affected: IC 5-2-1-13.5; IC 9-29-1-4.5.

Synopsis: Law enforcement academies. Imposes a \$1 fee on each bureau of motor vehicles transaction on which a fee already is imposed. Deposits the fees in the statewide law enforcement training fund to provide additional funding to law enforcement academies and training centers that: (1) are certified by the law enforcement training board; and (2) provide basic training to law enforcement officers. Makes a continuous appropriation.

Effective: July 1, 2016.

SENATE BILL No. 24

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 5-2-1-13.5 IS ADDED TO THE INDIANA CODE
- 2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 3 1, 2016]: **Sec. 13.5. (a) As used in this section, "eligible academy"**
- 4 **means a board certified:**
- 5 (1) **law enforcement academy, including a law enforcement**
- 6 **training academy established under section 10.5 of this**
- 7 **chapter; or**
- 8 (2) **training center under section 15.2 of this chapter;**
- 9 **that provides basic training to law enforcement officers.**
- 10 (b) **The statewide law enforcement training fund is established**
- 11 **for the purpose of providing additional funding to eligible**
- 12 **academies. The board shall administer the fund.**
- 13 (c) **The fund consists of the following:**
- 14 (1) **Fees deposited under IC 9-29-1-10.**
- 15 (2) **Appropriations from the general assembly.**
- 16 (3) **Gifts, grants, and donations to the fund.**
- 17 (4) **Interest that accrues from money in the fund.**



1 (d) The expenses of administering the fund shall be paid from
2 money in the fund.

3 (e) The treasurer of state shall invest the money in the fund not
4 currently needed to meet the obligations of the fund in the same
5 manner as other public money may be invested. Interest that
6 accrues from these investments shall be deposited in the fund.

7 (f) Money in the fund at the end of a state fiscal year does not
8 revert to the state general fund.

9 (g) The board shall adopt rules under IC 4-22-2 to distribute
10 money in the fund to eligible academies.

11 (h) All money deposited in the fund is continuously
12 appropriated for the purposes of the fund.

13 SECTION 2. IC 9-29-1-4.5 IS ADDED TO THE INDIANA CODE
14 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
15 1, 2016]: Sec. 4.5. (a) A law enforcement training fee of one dollar
16 (\$1) is imposed on each transaction for which a fee is imposed or
17 collected by the bureau. The fee is in addition to all other fees
18 collected by the bureau, including any fees under the following:

19 (1) IC 9-14.

20 (2) IC 9-16.

21 (3) IC 9-17.

22 (4) IC 9-18.

23 (5) IC 9-20.

24 (6) IC 9-22.

25 (7) IC 9-24.

26 (8) IC 9-25.

27 (9) IC 9-27.

28 (b) Money collected under subsection (a) shall be deposited in
29 the statewide law enforcement training fund established by
30 IC 5-2-1-13.5 and shall be expended for the purposes of the fund.
