SENATE BILL No. 64

DIGEST OF SB 64 (Updated January 27, 2020 2:46 pm - DI 125)

Citations Affected: IC 21-17.

Synopsis: Indiana youth service program. Provides that the Center of Excellence in Leadership of Learning at the University of Indianapolis shall develop a proposal to establish the Indiana youth service program (program) to provide high school students with the opportunity to learn various skills and participate in service at host sites throughout Indiana. Provides that the Center of Excellence in Leadership of Learning at the University of Indianapolis may seek input on the program from the department of workforce development, the commission for higher education, and the legislative services agency. Provides that the Center of Excellence in Leadership of Learning at the University of Indianapolis shall present the proposed program, including costs of administration, to the budget committee and the general assembly for review and consideration not later than December 1, 2020.

SENATE BILL No. 64

A BILL FOR AN ACT to amend the Indiana Code concerning higher education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 21-17-7 IS ADDED TO THE INDIANA CODE AS
2 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2020]:
4 **Chapter 7. Indiana Youth Service Program**
5 **Sec. 1. As used in this chapter, "program" refers to the Indiana**
6 **youth service program proposed under section 2 of this chapter.**
7 **Sec. 2. (a) Not later than December 1, 2020, the Center of**
8 **Excellence in Leadership of Learning at the University of**
9 **Indianapolis shall develop a proposal to establish the Indiana youth**
10 **service program to do the following:**
11 **(1) Encourage young people to remain in Indiana after**
12 **graduating from high school.**
13 **(2) Provide program participants with the skills that will**
14 **enable them to successfully make the transition from high**
15 **school to:**
16 **(A) an institution of higher education; or**
17 **(B) the workforce.**

1 **(3) Provide a model of social engagement for young people,**
 2 **and encourage relationships among young people across**
 3 **diverse communities.**

4 **(4) Encourage a culture of civic participation, and promote**
 5 **democracy.**

6 **(b) The program shall consist of a ten (10) week summer**
 7 **program between a student's junior year and senior year of high**
 8 **school.**

9 **(c) The Center of Excellence in Leadership of Learning at the**
 10 **University of Indianapolis will administer the program.**

11 **Sec. 3. (a) In developing the program, the Center of Excellence**
 12 **in Leadership of Learning at the University of Indianapolis shall**
 13 **provide for the inclusion of a selection committee that shall review**
 14 **applications and select potential participants for the program as**
 15 **part of a competitive application process. The selection committee**
 16 **shall consist of members to be determined by the general assembly**
 17 **at a later date.**

18 **(b) The chair of the selection committee shall establish the**
 19 **meeting times and dates for the selection committee.**

20 **(c) Each member of the selection committee who is not a state**
 21 **employee is entitled to the minimum salary per diem provided by**
 22 **IC 4-10-11-2.1(b). The member is also entitled to reimbursement**
 23 **for traveling expenses as provided under IC 4-13-1-4 and other**
 24 **expenses actually incurred in connection with the member's duties**
 25 **as provided in the state policies and procedures established by the**
 26 **Indiana department of administration and approved by the budget**
 27 **agency.**

28 **(d) Each member of the selection committee who is a state**
 29 **employee is entitled to reimbursement for traveling expenses as**
 30 **provided under IC 4-13-1-4 and other expenses actually incurred**
 31 **in connection with the member's duties as provided in the state**
 32 **policies and procedures established by the Indiana department of**
 33 **administration and approved by the budget agency.**

34 **Sec. 4. (a) Except as provided in subsection (b), the selection**
 35 **committee described in section 3 of this chapter may consider a**
 36 **student's application only if the student meets the following**
 37 **requirements:**

38 **(1) Is a resident of Indiana.**

39 **(2) Is entering grade 11 at a:**

40 **(A) public school, including a charter school;**

41 **(B) nonpublic school that is accredited by either the state**
 42 **board of education or a national or regional accreditation**



- 1 agency that is recognized by the state board of education;
 2 or
 3 (C) nonaccredited nonpublic school.
- 4 (b) In addition to a student who meets the minimum
 5 requirements under subsection (a), the selection committee may
 6 consider a student who:
- 7 (1) before or during grade 10 is placed by or with the consent
 8 of the department of child services, by a court order, or by a
 9 child placing agency in:
- 10 (A) a foster family home;
 11 (B) the home of a relative or other unlicensed caretaker;
 12 (C) a child caring institution; or
 13 (D) a group home; and
- 14 (2) meets the requirements in subsection (a)(1) through (a)(2).
- 15 (c) The selection committee shall consider an applicant's
 16 curiosity, work ethic, and enthusiasm for serving others in
 17 determining whether the applicant may be selected for
 18 consideration as a program participant.
- 19 (d) In selecting potential program participants, the selection
 20 committee shall strive to ensure that each group of program
 21 participants embodies Indiana's socioeconomic, geographic, racial,
 22 religious, ethnic, and political diversity.
- 23 Sec. 5. (a) As part of the proposal described in section 2 of this
 24 chapter, the Center of Excellence in Leadership of Learning at the
 25 University of Indianapolis shall select entities to serve as service
 26 host sites for program participants. The Center of Excellence in
 27 Leadership of Learning at the University of Indianapolis shall
 28 consider:
- 29 (1) the entity's capacity to engage participants in meaningful
 30 activities targeted to college, career exploration, and public
 31 service; and
 32 (2) the entity's ability to ensure a variety of experiences for
 33 participants;
- 34 when selecting an entity as a service host site.
- 35 (b) The Center of Excellence in Leadership of Learning at the
 36 University of Indianapolis may also consider the entity's ability to
 37 contribute to the costs of hosting program participants, including
 38 housing costs, if needed.
- 39 (c) In considering the criteria set forth in subsections (a) and (b),
 40 the Center of Excellence in Leadership of Learning at the
 41 University of Indianapolis shall strive to include a diverse array of
 42 entities as service host sites, including but not limited to:



- 1 **(1) private employers in the areas of:**
- 2 **(A) advanced manufacturing;**
- 3 **(B) building and construction;**
- 4 **(C) health and life sciences;**
- 5 **(D) information technology and business services;**
- 6 **(E) transportation and logistics; and**
- 7 **(F) agriculture;**
- 8 **(2) nonprofit, faith based, and community organizations;**
- 9 **(3) school corporations and charter schools; and**
- 10 **(4) political subdivisions.**
- 11 **Sec. 6. The Center of Excellence in Leadership of Learning at**
- 12 **the University of Indianapolis may seek input about the proposal**
- 13 **from other entities, including but not limited to:**
- 14 **(1) the department of workforce development;**
- 15 **(2) the commission for higher education; and**
- 16 **(3) the legislative services agency.**
- 17 **Sec. 7. In developing the proposal, the Center of Excellence in**
- 18 **Leadership of Learning at the University of Indianapolis shall**
- 19 **explore the possibility of:**
- 20 **(1) accessing federal or other grant funding for the program;**
- 21 **and**
- 22 **(2) awarding program participants with academic credit,**
- 23 **certification, or scholarships for service in the program.**
- 24 **Sec. 8. Not later than December 1, 2020, the Center of**
- 25 **Excellence in Leadership of Learning at the University of**
- 26 **Indianapolis shall submit the proposed program, including the**
- 27 **projected costs of administration, to the budget committee**
- 28 **established by IC 4-12-1-3 and, in an electronic format under**
- 29 **IC 5-14-6, to the general assembly for review and consideration.**
- 30 **Sec. 9. This chapter expires July 1, 2025.**

Madam President: The Senate Committee on Pensions and Labor, to which was referred Senate Bill No. 64, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Delete the title and insert the following:

A BILL FOR AN ACT to amend the Indiana Code concerning higher education and to make an appropriation.

Page 2, line 8, after "Indiana" insert "**through its member schools and subcontractors**".

Page 2, line 14, delete "the following four (4) members:" and insert "**members to be determined by the general assembly at a later date.**".

Page 2, delete lines 15 through 22.

Page 3, line 33, delete "work;" and insert "**activities targeted to college, career exploration, and public service;**".

Page 4, after line 28, begin a new paragraph and insert:

"SECTION 2. [EFFECTIVE JULY 1, 2020] (a) There is appropriated to the Center of Excellence in Leadership of Learning at the University of Indianapolis thirty thousand dollars (\$30,000) from the state general fund beginning July 1, 2020, and ending June 30, 2021, for the purpose of developing a proposal to establish the Indiana youth service program under IC 21-17-7, as added by this act.

(b) This SECTION expires July 1, 2021."
