# **SENATE BILL No. 76**

DIGEST OF SB 76 (Updated February 21, 2019 1:16 pm - DI 106)

Citations Affected: IC 35-50.

**Synopsis:** Sentencing. Makes dealing in a Schedule I or II narcotic drug as a Level 2 felony nonsuspendible if the person has a prior unrelated felony conviction for certain drug dealing offenses.

Effective: July 1, 2019.

## **SENATE BILL No. 76**

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 35-50-2-2.2, AS AMENDED BY P.L.252-2017,
2	SECTION 27, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	JULY 1, 2019]: Sec. 2.2. (a) Except as provided in subsection (b), (c),
4	(d), or (e), the court may suspend any part of a sentence for a felony.
5	(b) Except as provided in subsection (d), if a person is convicted of
6	a Level 2 felony or a Level 3 felony, except a Level 2 felony or a Level
7	3 felony concerning a controlled substance under IC 35-48-4, and has
8	any prior unrelated felony conviction, the court may suspend only that
9	part of a sentence that is in excess of the minimum sentence for the:
10	(1) Level 2 felony; or
11	(2) Level 3 felony.
12	(c) If:
13	(1) a person has a prior unrelated felony conviction in any
14	jurisdiction for dealing in a controlled substance that is not
15	marijuana, hashish, hash oil, salvia divinorum, or a synthetic
16	drug, including an attempt or conspiracy to commit the offense;

1	(2) the person is convicted of a Level 2 felony under:
2	(A) IC 35-48-4-1 for an offense involving a narcotic drug;
3	<b>(B)</b> IC 35-48-4-1.1; or
4	<b>(C)</b> IC 35-48-4-1.2;
5	the court may suspend only that part of a sentence that is in excess of
6	the minimum sentence for the Level 2 felony.
7	(d) If a person:
8	(1) is convicted of dealing in heroin as a Level 2 or Level 3 felony
9	under IC 35-48-4-1 or IC 35-48-4-2; and
10	(2) has a prior unrelated felony conviction;
11	the court may suspend only that part of a sentence that is in excess of
12	the minimum sentence for the Level 2 or Level 3 felony.
13	(e) The court may suspend only that part of a sentence for murder
14	or a Level 1 felony conviction that is in excess of the minimum
15	sentence for murder or the Level 1 felony conviction.
