

SENATE BILL No. 98

DIGEST OF SB 98 (Updated January 22, 2020 2:41 pm - DI 104)

Citations Affected: IC 16-18; IC 25-22.5; IC 25-23.

Synopsis: Certified registered nurse anesthetists. Requires a physician to be available for timely consultation with a certified registered nurse anesthetist who is administering anesthesia under the direction of the physician during a surgical procedure (current law requires the physician to remain present in the facility). Allows for a certified registered nurse anesthetist to administer anesthesia under the direction of a podiatrist in a hospital or ambulatory outpatient surgical center if a physician is available for a timely consultation. Provides that: (1) the National Board of Certification and Recertification for Nurse Anesthetists; or (2) another certifying entity approved by the Indiana state board of nursing; may act as a certifying or recertifying entity for certified registered nurse anesthetists.

Effective: July 1, 2020.

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

17	(7) Does not provide accommodations for patient stays of longer
18	than twenty-four (24) hours.
19	(8) Provides full-time services of registered and licensed nurses
20	for the professional care of the patients in the postanesthesia
21	recovery room.
22	(9) Has available the necessary equipment and trained personnel
23	to handle foreseeable emergencies such as a defibrillator for
24	cardiac arrest, a tracheotomy set for airway obstructions, and a
25	blood bank or other blood supply.
26	(10) Maintains a written agreement with at least one (1) hospital
27	for immediate acceptance of patients who develop complications
28	or require postoperative confinement.
29	(11) Provides for the periodic review of the center and the center's
30	operations by a committee of at least three (3) licensed physicians
31	having no financial connections with the center.
32	(12) Maintains adequate medical records for each patient.
33	(13) Meets all additional minimum requirements as established by
34	the state department for building and equipment requirements.
35	(14) Meets the rules and other requirements established by the
36	state department for the health, safety, and welfare of the patients.
37	(b) The term does not include a birthing center.
38	SECTION 2. IC 25-22.5-1-2, AS AMENDED BY P.L.180-2018,
39	SECTION 19, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
40	JULY 1, 2020]: Sec. 2. (a) This article, as it relates to the unlawful or
41	unauthorized practice of medicine or osteopathic medicine, does not

apply to any of the following:

1	(1) A student in training in a medical school approved by the
2	board, or while performing duties as an intern or a resident in a
3	hospital under the supervision of the hospital's staff or in a
4	program approved by the medical school.
5	(2) A person who renders service in case of emergency where no
6	fee or other consideration is contemplated, charged, or received.
7	(3) A paramedic (as defined in IC 16-18-2-266), an advanced
8	emergency medical technician (as defined in IC 16-18-2-6.5), an
9	emergency medical technician (as defined in IC 16-18-2-112), or
10	a person with equivalent certification from another state who
11	renders advanced life support (as defined in IC 16-18-2-7), or
12	basic life support (as defined in IC 16-18-2-33.5):
13	(A) during a disaster emergency declared by the governor
14	under IC 10-14-3-12 in response to an act that the governor in
15	good faith believes to be an act of terrorism (as defined in
16	IC 35-31.5-2-329); and
17	(B) in accordance with the rules adopted by the Indiana
18	emergency medical services commission or the disaster
19	emergency declaration of the governor.
20	(4) Commissioned medical officers or medical service officers of
21	the armed forces of the United States, the United States Public
22	Health Service, and medical officers of the United States
23	Department of Veterans Affairs in the discharge of their official
24	duties in Indiana.
25	(5) An individual who is not a licensee who resides in another
26	state or country and is authorized to practice medicine or
27	osteopathic medicine there, who is called in for consultation by an
28	individual licensed to practice medicine or osteopathic medicine
29	in Indiana.
30	(6) A person administering a domestic or family remedy to a
31	member of the person's family.
32	(7) A member of a church practicing the religious tenets of the
33	church if the member does not make a medical diagnosis,
34	prescribe or administer drugs or medicines, perform surgical or
35	physical operations, or assume the title of or profess to be a
36	physician.
37	(8) A school corporation and a school employee who acts under
38	IC 34-30-14 (or IC 34-4-16.5-3.5 before its repeal).
39	(9) A chiropractor practicing the chiropractor's profession under
40	IC 25-10 or to an employee of a chiropractor acting under the
41	direction and supervision of the chiropractor under IC 25-10-1-13.
42	(10) A dental hygienist practicing the dental hygienist's profession

39	(c) An employment or other contractual relationship between an

41	physician does not constitute the unlawful practice of medicine or
42	osteopathic medicine under this article if the entity does not direct or



- control independent medical acts, decisions, or judgment of the licensed physician. However, if the direction or control is done by the entity under IC 34-30-15 (or IC 34-4-12.6 before its repeal), the entity is excluded from the application of this article as it relates to the unlawful practice of medicine or osteopathic medicine.
- (d) This subsection does not apply to a prescription or drug order for a legend drug that is filled or refilled in a pharmacy owned or operated by a hospital licensed under IC 16-21. A physician licensed in Indiana who permits or authorizes a person to fill or refill a prescription or drug order for a legend drug except as authorized in IC 16-42-19-11 through IC 16-42-19-19 is subject to disciplinary action under IC 25-1-9. A person who violates this subsection commits the unlawful practice of medicine or osteopathic medicine under this chapter.
- (e) A person described in subsection (a)(8) shall not be authorized to dispense contraceptives or birth control devices.

SECTION 3. IC 25-23-1-1.4, AS AMENDED BY P.L.177-2009, SECTION 42, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2020]: Sec. 1.4. As used in this chapter, "certified registered nurse anesthetist" means a registered nurse who:

- (1) is a graduate of a nurse anesthesia educational program accredited by the Council on Accreditation of Nurse Anesthesia Educational Programs or its predecessor;
- (2) is properly certified by successfully completing the certification examination administered by the Council on Certification of Nurse Anesthetists or its predecessor; National Board of Certification and Recertification for Nurse Anesthetists or another certifying entity approved by the board; and
- (3) is properly certified and in compliance with criteria for biennial recertification, as defined by the Council on Recertification of Nurse Anesthetists. National Board of Certification and Recertification for Nurse Anesthetists or another certifying entity approved by the board.

SECTION 4. IC 25-23-1-30, AS AMENDED BY P.L.177-2009, SECTION 44, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,2020]: Sec. 30. (a) A certified registered nurse anesthetist may administer anesthesia if the certified registered nurse anesthetist acts under the direction of and in the immediate presence of a physician and if the directing physician is available for timely consultation. A certified registered nurse anesthetist may administer anesthesia under the direction of a podiatrist in a hospital or an ambulatory outpatient surgical center (as defined in IC 16-18-2-14) if a



1	physician	is avail	able for	timely	consultation.

2 (b) Nothing in this chapter shall be construed as requiring a certified registered nurse anesthetist to obtain prescriptive authority to administer anesthesia under subsection (a).
