

## SENATE BILL No. 99

DIGEST OF SB 99 (Updated January 27, 2020 12:42 pm - DI 133)

Citations Affected: Noncode.

**Synopsis:** Study committee on invasive species. Urges the legislative council to assign to an appropriate interim study committee (committee) the topic of studying issues related to invasive species. Specifies that the committee must consider the following: (1) An examination of the Indiana Invasives Initiative, including: (A) funding sources available to the Indiana Invasives Initiative; and (B) the potential for making the Indiana Invasives Initiative an agency of state government. (2) Funding sources available to the invasive species council.

Effective: Upon passage.

## SENATE BILL No. 99

A BILL FOR AN ACT concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. [EFFECTIVE UPON PASSAGE] (a) The legislative
2	council is urged to assign to an appropriate interim study
3	committee the topic of studying issues related to invasive species.
4	(b) If the legislative council assigns the topic under subsection
5	(a), the study must include consideration of the following:
6	(1) An examination of the Indiana Invasives Initiative
7	including:
8	(A) funding sources available to the Indiana Invasives
9	Initiative; and
0	(B) the potential for making the Indiana Invasives
1	Initiative an agency of state government.
2	(2) Funding sources available to the invasive species council
3	established by IC 15-16-10.
4	(c) This SECTION expires January 1, 2021.
5	SECTION 2. An emergency is declared for this act.
