DIGEST OF INTRODUCED BILL

Citations Affected: IC 4-3-25.

Synopsis: Commission to combat drug abuse. Adds one member of the clergy of a religious organization appointed by the governor to the membership of the Indiana commission to combat drug abuse. Makes a conforming change.

Effective: July 1, 2019.

A BILL FOR AN ACT to amend the Indiana Code concerning state offices and administration.

Be it enacted by the General Assembly of the State of Indiana:

 24 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 25 JULY 1, 2019]: Sec. 5. (a) The member of the governor's staff
 26 appointed under section 4(1) of this chapter shall serve as the
 27 chairperson of the commission. The chairperson shall determine the
 28 agenda for the commission.
 29 (b) The member at large appointed under section ~~4(19)~~ **4(20)** of this
 30 chapter shall serve as vice chairperson of the commission. The
 31 chairperson shall determine the duties of the vice chairperson.
