ENGROSSED SENATE BILL No. 189

DIGEST OF SB 189 (Updated March 18, 2019 5:14 pm - DI 119)

Citations Affected: IC 25-35.6; noncode.

Synopsis: Emergency communication disorder permits. Allows the department of education to issue an emergency communication disorder permit to an individual to serve the needs of certain students who are eligible for speech and language services. Provides that the director of a graduate program in communication disorders shall confirm to the department of education that an individual is complying with certain emergency communication disorder permit requirements. Requires the Indiana professional licensing agency, in consultation with the department of education, the office of educator effectiveness and licensing, the Indiana Council of Administrators of Special Education (ICASE), the Indiana Association of Public School Superintendents (IAPSS), the induital Association of Fubic School audiology board, and the Indiana Speech-Language pathology and Association (ISHA) to: (1) examine the requirements for licensure as a speech-language pathologist or audiologist in Indiana; and (2) not later than July 1, 2020, issue to the general assembly a report containing recommendations for streamlining the process for obtaining a license as a speech-language pathologist or audiologist in Indiana.

ENGROSSED SENATE BILL No. 189

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 25-35.6-1-8.6 IS ADDED TO THE INDIANA
2	CODE AS A NEW SECTION TO READ AS FOLLOWS
3	[EFFECTIVE UPON PASSAGE]: Sec. 8.6. (a) The department of
4	education may issue an emergency communication disorder permit
5	to an individual, as necessary, to serve the needs of students who
6	are eligible for speech and language services under the federal
7	Individuals with Disabilities Education Improvement Act (20
8	U.S.C. 1400 et seq.).
9	(b) To be eligible to receive an emergency communication
10	disorder permit, an individual must:
11	(1) have a bachelor's degree in speech, language, and hearing
12	sciences or an equivalent bachelor's degree in this subject
13	area; and
14	(2) be enrolled, and have submitted a verified plan of study, in
15	a graduate program in communication disorders.
16	(c) The director of a graduate program in communication
17	disorders shall, at the end of each semester or its equivalent,



1 confirm to the department of education, in a manner prescribed by 2 the department of education, that an individual described in 3 subsection (b) who: 4 (1) is enrolled in the graduate program; and 5 (2) holds an emergency communication disorder permit; 6 complies with subsection (b)(2). 7 (d) An individual who is issued an emergency communication 8 disorder permit shall have accessibility to a licensed 9 speech-language pathologist in order to collaborate on the 10 provision of services at no additional cost to the school corporation. 11 (e) An individual with an emergency communication disorder 12 permit may not use a title that states or implies that the individual 13 is a licensed speech-language pathologist. 14 (f) This section expires June 30, 2021. SECTION 2. [EFFECTIVE UPON PASSAGE] (a) The Indiana 15 16 professional licensing agency, in consultation with the department 17 of education, the office of educator effectiveness and licensing, the 18 Indiana Council of Administrators of Special Education (ICASE), 19 the Indiana Association of Public School Superintendents (IAPSS), 20 the speech-language pathology and audiology board, and the 21 Indiana Speech-Language-Hearing Association (ISHA), shall: 22 (1) examine the requirements for licensure as a 23 speech-language pathologist or audiologist in Indiana schools; 24 and 25 (2) not later than July 1, 2020, issue to the general assembly 26 a report containing recommendations for amendment of 27 IC 25-35.6 to streamline the process for obtaining a license as 28 a speech-language pathologist or audiologist in Indiana 29 schools. 30 The report issued to the general assembly under this SECTION 31 must be in an electronic format under IC 5-14-6. 32 (b) This SECTION expires December 31, 2020. 33 SECTION 3. An emergency is declared for this act.

Page 1, between lines 15 and 16, begin a new paragraph and insert:

"(c) The director of a graduate program in communication disorders shall, at the end of each semester or its equivalent, confirm to the department of education, in a manner prescribed by the department of education, that an individual described in subsection (b) who:

(1) is enrolled in the graduate program; and

(2) holds an emergency communication disorder permit; complies with subsection (b)(2).".

Page 1, line 16, delete "(c)" and insert "(d)".

Page 2, line 2, delete "(d)" and insert "(e)".

Page 2, line 6, delete "(e)" and insert "(f)".

Page 2, between lines 8 and 9, begin a new paragraph and insert:

"(g) This section expires June 30, 2021.".
