### **SENATE BILL No. 190**

DIGEST OF SB 190 (Updated January 29, 2019 1:37 pm - DI 132)

Citations Affected: IC 5-16; IC 9-18.5.

**Synopsis:** Modified symbol of access. Requires that parking signs for accessible parking spaces for an individual with a physical disability must bear, instead of the international symbol of accessibility (also known as the international wheelchair symbol), the modified symbol of access when erected, replaced, or repaired after December 31, 2019. Requires that license plates and placards issued by the bureau of motor vehicles for display in or on a vehicle used to transport a person with a disability must bear, rather than the international symbol of accessibility, the modified symbol of access on all new license plates or duplicate or replacement plates after December 31, 2019.

Effective: January 1, 2020.

## **SENATE BILL No. 190**

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:
