SENATE BILL No. 197

DIGEST OF SB 197 (Updated February 19, 2020 5:36 pm - DI 135)

Citations Affected: IC 1-1.

Synopsis: Prohibited technology purchases. Defines "prohibited person" as a person that has been designated as posing a national security threat to the integrity of communications networks or the communications supply chain under a Federal Communications Commission rule. Prohibits money appropriated by the general assembly or a political subdivision from being granted to or used to purchase or obtain any equipment or services produced or provided by a prohibited person.

Effective: Upon passage.

ENGROSSED SENATE BILL No. 197

A BILL FOR AN ACT to amend the Indiana Code concerning state offices and administration.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 1-1-15 IS ADDED TO THE INDIANA CODE AS
2 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE UPON
3 PASSAGE]:

4 **Chapter 15. Prohibited Technology Purchases**

5 **Sec. 1. As used in this chapter, "political subdivision" has the**
6 **meaning set forth in IC 36-1-2-13.**

7 **Sec. 2. As used in this chapter, "prohibited person" refers to a**
8 **person that has been designated as posing a national security**
9 **threat to the integrity of communications networks or the**
10 **communications supply chain under 47 CFR 54.9.**

11 **Sec. 3. As used in this chapter, "state agency" means an**
12 **authority, board, branch, commission, committee, department,**
13 **division, or other instrumentality of any of the following:**

- 14 (1) The executive, including the administrative department of
15 state government.
16 (2) The legislative department of state government.
17 (3) The judicial department of state government.

1 **(4) A state educational institution.**
2 **(5) A body corporate and politic created by statute.**
3 **Sec. 4. Money appropriated by the general assembly or a**
4 **political subdivision may not be granted to or used to purchase or**
5 **obtain any equipment or services produced or provided by a**
6 **prohibited person.**
7 **Sec. 5. A prohibited person is not considered responsible or best**
8 **for purposes of determining whether a bidder or offeror is**
9 **responsible or best under any of the following:**
10 **(1) IC 4-13.6.**
11 **(2) IC 5-16.**
12 **(3) IC 5-22.**
13 **(4) IC 8-23-9.**
14 **(5) IC 36-1-12.**
15 **(6) Any other statute under which a state agency or political**
16 **subdivision awards a contract.**
17 **SECTION 2. An emergency is declared for this act.**
