## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 36-3-7-7.

**Synopsis:** Marion County fairgrounds. Provides that the board of directors of the Marion County Agricultural Fair Association may request the placement of one digital billboard at a location on the real property of the Marion County Agricultural Fair Association selected by the board. Provides that a consolidated city shall permit the placement of one digital billboard on the real property of the Marion County Agricultural Fair Association if the board makes such a request. Provides that the owner of the real property of the Marion County Agricultural Fair Association shall receive any revenue attributable to the placement of the digital billboard on the real property.

**Effective:** July 1, 2020.

# SENATE BILL No. 215

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 36-3-7-7 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2020]: **Sec. 7. (a) As used in this section, "board" refers to the**  
4 **board of directors of the Marion County Agricultural Fair**  
5 **Association, Inc.**  
6 **(b) As used in this section, "real property" means the real**  
7 **property of the Marion County Agricultural Fair Association, Inc.,**  
8 **located at 7300 East Troy Avenue Indianapolis, IN 46239 (parcel**  
9 **number 7007720).**  
10 **(c) The board may request the placement of one (1) digital**  
11 **billboard at a location on the real property selected by the board.**  
12 **(d) This subsection applies if the board makes the request**  
13 **described in subsection (c). Notwithstanding IC 36-7-4 or any**  
14 **ordinance adopted under IC 36-7-4, the consolidated city shall**  
15 **permit the placement of one (1) digital billboard on the real**  
16 **property. However, the digital billboard may not be located on any**  
17 **land within the public right-of-way.**



1           **(e) The owner of the real property shall receive any revenue**  
2           **attributable to the placement of the digital billboard on the real**  
3           **property.**
