### DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 21-48-2.

**Synopsis:** Information on student identification cards. Requires an approved postsecondary educational institution that receives financial aid administered by the commission for higher education and issues a student identification card to include the following information on the student identification card: (1) A statement regarding sexual violence services. (2) The name and Internet web site for the live chat service of the Rape, Abuse & Incest National Network (RAINN). (3) The number for the national sexual assault telephone hotline.

A BILL FOR AN ACT to amend the Indiana Code concerning higher education.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 21-48-2 IS ADDED TO THE INDIANA CODE AS  
2 A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY

4 **Chapter 2. Information Required on Student Identification**  
5 **Cards**

6 **Sec. 1. This chapter applies only to an approved postsecondary**  
7 **educational institution that receives financial aid administered or**  
8 **distributed by the commission.**

9 **Sec. 2. If an approved postsecondary educational institution**  
10 **issues to a student of the approved postsecondary educational**  
11 **institution a student identification card, the approved**  
12 **postsecondary educational institution shall include the following**  
13 **information on the student identification card:**

- 14 (1) **The following statement:**  
15 **"If you have experienced sexual violence, free support is**  
16 **available to you through live chat, text, or telephone."**
