

SENATE BILL No. 294

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-19-3.

Synopsis: Education reports. Provides that the department of education (department) shall post on the department's Internet web site the following: (1) The cash balance of each school corporation's education fund on June 30 of the immediately preceding school year. (2) The cash balance of the school corporation's rainy day fund on June 30 of the immediately preceding school year. (3) The most recently adopted school corporation budget. Provides that the department shall continue to develop, update, and publish reports that were developed, updated, and published between January 2017 and December 2020 by the department. Requires each report to use the same points of analysis used in the reports developed, updated, and published by the department between January 2017 and December 2020.

Effective: Upon passage.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

11 SECTION 2. IC 20-19-3-25 IS ADDED TO THE INDIANA CODE
12 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE
13 UPON PASSAGE]: **Sec. 25. (a) Notwithstanding any other law, the**
14 **department shall continue to develop, update, and publish reports**
15 **annually that were developed, updated, and published by the**
16 **department between January 2017 and December 2020.**
17 (b) **Notwithstanding any other law, each report under**

4 SECTION 3. An emergency is declared for this act.
