SENATE BILL No. 345

DIGEST OF SB 345 (Updated January 29, 2015 10:51 am - DI 120)

Citations Affected: IC 12-32; IC 21-14.

Synopsis: Resident tuition rate. Provides that an individual, except for certain nonimmigrants, who: (1) attends a high school in Indiana for at least three years; (2) registers as an entering student at or is currently enrolled in a state educational institution not earlier than the fall semester (or its equivalent, as determined by the state educational institution) of the 2015-2016 academic year; and (3) graduated from a high school located in Indiana or received the equivalent of a high school diploma in Indiana; is eligible for the resident tuition rate. Requires such an individual to verify that the individual meets the criteria to receive the resident tuition rate. Sunsets the law on June 30, 2017.

Effective: July 1, 2015.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 17 **Chapter 11.5. Resident Tuition Rate**
- 18 **Sec. 1. (a) This section does not apply to an individual who is a**
19 **nonimmigrant alien as described in 8 U.S.C. 1101(a)(15).**
- 20 (b) Except as otherwise provided under federal law, an
21 individual is eligible to pay the resident tuition rate that is
22 determined by a state educational institution if:
- 23 (1) the individual attended a high school in Indiana for at least
24 three (3) years;
- 25 (2) the individual:
- 26 (A) registers as an entering student at; or
27 (B) is currently enrolled in;
28 a state educational institution not earlier than the fall
29 semester (or its equivalent, as determined by the state
30 educational institution) of the 2015-2016 academic year; and
- 31 (3) the individual:
- 32 (A) graduated from a high school located in Indiana; or
33 (B) received the equivalent of a high school diploma in
34 Indiana.
- 35 (c) This chapter expires June 30, 2017.

"(c) This chapter expires June 30, 2017."
