SENATE BILL No. 356

DIGEST OF INTRODUCED BILL

Citations Affected: IC 5-20-10.

Synopsis: Healthy food finance. Establishes the healthy food financing fund (fund) and healthy food financing program (program) under the administration of the Indiana housing and community development authority (IHCDA). Provides that the purpose of the fund is to provide financing in the form of loans or grants for projects that increase the availability of fresh and nutritious food in underserved communities. Defines an "underserved community" as a census tract determined to be an area with low supermarket access: (1) by the United States Department of Agriculture; or (2) as identified through a methodology used by another healthy food initiative. Provides that the IHCDA may contract with one or more nonprofit organizations or community development financial institutions to administer the program through a public-private partnership. Provides that an applicant for a grant or a loan must demonstrate the capacity to successfully implement the project and the ability to repay the loan. Provides that an applicant for a grant or a loan must agree to satisfy certain conditions. Requires the IHCDA to monitor projects receiving financing and submit a report annually to the legislative council that includes the number and types of jobs created, and the health initiatives associated with the program.

A BILL FOR AN ACT to amend the Indiana Code concerning state offices and administration.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1, IC 5-20-10 IS ADDED TO THE INDIANA CODE AS

2	A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
3	1, 2020]:
4	Chapter 10. Healthy Food Financing Program
5	Sec. 1. As used in this chapter, "development authority" refers
6	to the Indiana housing and community development authority
7	created by IC 5-20-1-3.
8	Sec. 2. As used in this chapter, "financing" means:
9	(1) loans (including forgivable loans); or
10	(2) grants.
11	Sec. 3. As used in this chapter, "fund" refers to the healthy food
12	financing fund established by section 9 of this chapter.
13	Sec. 4. As used in this chapter, "grocery store" means a
14	for-profit or nonprofit self-service retail establishment that
15	primarily sells meat, seafood, fruits, vegetables, dairy products,
16	dry groceries, household products, and sundries.
17	Sec. 5. As used in this chapter, "low income area" means a



1	census tract (as reported in the most recently completed decennial
2	census published by the U.S. Bureau of the Census):
3	(1) that has a poverty rate of at least twenty percent (20%);
4	or
5	(2) in which the median family income is not more than eighty
6	percent (80%) of the greater of:
7	(A) the median family income in Indiana; or
8	(B) if applicable, the metropolitan median family income.
9	Sec. 6. As used in this chapter, "moderate income area" means
10	a census tract in which the median family income is more than
11	eighty percent (80%) but not more than ninety-five percent (95%)
12	of the median family income in Indiana.
13	Sec. 7. As used in this chapter, "program" refers to the healthy
14	food financing program conducted under section 10 of this chapter.
15	Sec. 8. As used in this chapter, "underserved community"
16	means a census tract determined to be an area with low
17	supermarket access:
18	(1) by the United States Department of Agriculture, as
19	identified in its Food Access Research Atlas; or
20	(2) as identified through a methodology that has been adopted
21	for use by another governmental or philanthropic healthy
22	food initiative.
23	Sec. 9. (a) The healthy food financing fund is established. The
24	purpose of the fund is to provide financing for projects that
25	increase the availability of fresh and nutritious food in underserved
26	communities, including financing for retailers to open, renovate, or
27	expand grocery stores. The fund shall be administered by the
28	development authority.
29	(b) The fund consists of the following:
30	(1) Appropriations by the general assembly.
31	(2) Donations.
32	(3) Federal grants or other federal appropriations.
33	(4) Interest and other earnings derived from investment of
34	money in the fund.
35	(c) Money in the fund at the end of a state fiscal year does not
36	revert to the state general fund.
37	(d) Money in the fund must be used, to the extent practicable, to
38	leverage other forms of financing.
39	(e) At least ten percent (10%) of the money in the fund shall be
40	reserved for administrative and operational costs to manage the
41	program, unless those costs are provided for from other budgets or

1	(f) The development authority may not expend annually more
2	than ten percent (10%) of the fund for administrative and
3	operational costs to manage the program.
4	Sec. 10. The development authority shall conduct, in
5	cooperation with public and private sector partners, a healthy food
6	financing program to provide financing for eligible projects as
7	described in section 12 of this chapter.
8	Sec. 11. The development authority may contract with one (1)
9	or more qualified nonprofit organizations or community
10	development financial institutions to administer the program
11	through a public-private partnership. The development authority
12	shall establish program guidelines, raise matching funds, promote
13	the program statewide, evaluate applicants, underwrite and
14	disburse grants and loans, and monitor compliance and impact.
15	Sec. 12. The development authority shall create eligibility
16	guidelines and provide financing through an application process.
17	Projects must be located in an underserved community and
18	primarily serve low income areas and moderate income areas. The
19	following projects are eligible for financing:
20	(1) Construction of new grocery stores.
21	(2) Grocery store, food bank, or food pantry renovations,
22	expansion, and infrastructure upgrades that improve the
23	availability and quality of fresh produce and other healthy
24	foods.
25	(3) Farmers' markets, farm stands and markets, community
26	supported agriculture programs, food cooperatives, mobile
27	markets, and delivery projects and distribution projects that
28	improve the availability and quality of fresh produce and
29	other healthy foods.
30	(4) Other projects, including outreach programs, that
31	improve the availability and quality of fresh produce and
32	other healthy foods.
33	Sec. 13. An applicant for financing under this chapter may be a
34	for-profit or nonprofit entity, including a sole proprietorship,
35	partnership, limited liability company, corporation, cooperative,
36	nonprofit organization, nonprofit community development entity,
37	university, or government entity. An applicant for financing must:
38	(1) demonstrate the capacity to successfully implement the
39	project and the likelihood that the project will be
40	economically self-sustaining;

(2) demonstrate the ability to repay the loan; and

(3) agree, for a period of not less than five (5) years, to comply

1	with the following conditions:
2	(A) If applicable, to accept, pending the accessibility of
3	technology, Supplemental Nutrition Assistance Program
4	(SNAP) benefits.
5	(B) If applicable, to accept, if approved, Special
6	Supplemental Nutrition Program for Women, Infants and
7	Children (WIC) benefits.
8	(C) If applicable, to allocate at least fifty percent (50%) of
9	food retail space for the sale of perishable foods, which
10	may include fresh or frozen dairy, fresh produce, whole
11	grains, fresh meats, poultry, and fish.
12	(D) To comply with all data collection and reporting
13	requirements established by the development authority.
14	(E) To promote the hiring of local residents.
15	(F) To require that any partner in the implementation of
16	a project under this chapter complies with clauses (A)
17	through (E).
18	Sec. 14. In determining which eligible projects to finance, the
19	development authority shall consider:
20	(1) the level of need in the area to be served;
21	(2) the degree to which the project requires an investment of
22	public financing to move forward, create impact, or be
23	competitive;
24	(3) the degree to which the project will have a positive
25	economic impact on the underserved community, including by
26	creating or retaining jobs for local residents;
27	(4) the degree to which the project will participate in state and
28	local health department initiatives to educate consumers on
29	nutrition and promote healthier eating; and
30	(5) other criteria that the development authority determines
31	to be consistent with the purposes of this chapter.
32	Sec. 15. Financing made available for projects under this
33	chapter may be used for the following purposes:
34	(1) Site acquisition and preparation.
35	(2) Construction and build-out costs.
36	(3) Equipment and furnishings.
37	(4) Workforce training or security.
38	(5) Predevelopment costs, such as market studies and
39	appraisals.
40	(6) Energy efficiency measures.
41	(7) Working capital for first time inventory and startup costs.
42	(8) Outreach and educational activities.



1	(9) Technology infrastructure and software development.
2	Sec. 16. The development authority shall establish monitoring
3	and accountability mechanisms for projects receiving financing
4	under this chapter and shall submit a report annually to the
5	legislative council on the projects funded, the geographic
6	distribution of the projects, the costs of the program, and the
7	outcomes, including the number and types of jobs created, and the
8	health initiatives associated with the program. The report
9	submitted to the legislative council must be in an electronic format
10	under IC 5-14-6.
