

SENATE BILL No. 357

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-50-2-3; IC 21-12.

Synopsis: Twenty-first century scholars program eligibility. Requires each school corporation to provide tutoring for children who: (1) are enrolled in a school operated by the school corporation; (2) are in foster care; and (3) have a demonstrated need for tutoring, as determined by the school corporation. Provides eligibility for: (1) participation in the twenty-first century scholars program; and (2) higher education awards; for individuals in grades 9 through 12 who are eligible for services under the McKinney-Vento Act.

Effective: July 1, 2020.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

17 JULY 1, 2020]: Sec. 1. This chapter applies to an individual who:



- 1 (1) is receiving foster care **or is eligible for services under the**
- 2 **McKinney-Vento Act;**
- 3 (2) is in grades 9 through 12; and
- 4 (3) is a resident of Indiana as determined under IC 21-18.5-4-8;
- 5 at the time the individual applies for the twenty-first century scholars
- 6 program under IC 21-12-6.
