DIGEST OF INTRODUCED BILL

Citations Affected: IC 12-15-2-2.5; IC 27-1-43.

Synopsis: Implementation of federal Affordable Care Act. Expands Medicaid coverage for specified individuals. Requires the department of insurance to create a state health benefit exchange in Indiana. Requires the legislative services agency to prepare legislation for introduction in the 2015 legislative session to make necessary changes to statutes affected by this act.

Effective: Upon passage.
