

# SENATE BILL No. 383

---

## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 4-13-16.5-4.5.

**Synopsis:** Reporting on MBE and WBE contracting goals. Requires the president of each state educational institution in Indiana, or the president's designee, to appear: (1) before the budget committee during each interim; and (2) in a budget year session, before the standing committees in the house of representatives and senate to which the state's biennial budget bill is assigned; at which the president, or the president's designee, shall present information and answer questions regarding the state educational institution's progress in achieving the goals established by the governor's commission on minority and women's business enterprises (commission) for the use of minority and women's business enterprises as contractors. Provides that, if the state educational institution did not meet the goals established by the commission in the most recent determination by the Indiana department of administration, the presentation must include a detailed statement of the policies adopted by the state educational institution intended to further its progress toward achieving the goals and an estimated time frame in which the state educational institution reasonably anticipates that the goals will be achieved.

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 4-13-16.5-4.5 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 2020]: **Sec. 4.5. Notwithstanding any other**  
4 **reporting requirement under this chapter, the president of each**  
5 **state educational institution, or the president's designee, shall**  
6 **appear:**  
7 (1) **before the budget committee during each interim; and**  
8 (2) **in a budget year session, before the standing committees in**  
9 **the house of representatives and senate to which the state's**  
10 **biennial budget bill is assigned;**  
11 **at which the president, or the president's designee, shall present**  
12 **information and answer questions regarding the state educational**  
13 **institution's progress in achieving the goals established under**  
14 **section 2(f)(8) of this chapter for the use of minority and women's**  
15 **business enterprises as contractors. If the state educational**  
16 **institution did not meet those goals in the most recent**  
17 **determination by the department under section 4 of this chapter,**



1     **the presentation must include a detailed statement of the policies**  
2     **adopted by the state educational institution intended to further its**  
3     **progress toward achieving the goals under section 2(f)(8) of this**  
4     **chapter and an estimated time frame in which the state educational**  
5     **institution reasonably anticipates that it will achieve the goals**  
6     **under section 2(f)(8) of this chapter.**
