DIGEST OF SB 383 (Updated February 19, 2020 3:33 pm - DI 134)

**Citations Affected:** IC 4-13.

**Synopsis:** Reporting on MBE and WBE contracting goals. Requires each state educational institution in Indiana to submit an annual report to the state budget committee regarding the state educational institution's progress in achieving the goals established by the governor's commission on minority and women's business enterprises for the use of minority and women's business enterprises as contractors.

**Effective:** July 1, 2020.

## ENGROSSED SENATE BILL No. 383

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

*Be it enacted by the General Assembly of the State of Indiana:*

1           SECTION 1. IC 4-13-16.5-4.5 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 2020]: **Sec. 4.5. Notwithstanding any other**  
4 **reporting requirement under this chapter, each state educational**  
5 **institution shall annually submit to the budget committee the**  
6 **report required by the commission under this chapter not later**  
7 **than December 1 after the close of each state fiscal year regarding**  
8 **the state educational institution's progress in achieving the goals**  
9 **established under section 2 of this chapter for the use of minority**  
10 **business enterprises, women's business enterprises, and veteran**  
11 **owned small businesses as contractors. The budget committee shall**  
12 **review the report.**
