DIGEST OF INTRODUCED BILL

Citations Affected: IC 21-12-6-7.

Synopsis: 21st century scholars program. Provides that the commission for higher education may allow a twenty-first century scholars program student who fulfills the observance of a religious discipline or call to mission to delay enrollment in a college or university or to meet course completion requirements for a period of up to two years.

Effective: July 1, 2020.

A BILL FOR AN ACT to amend the Indiana Code concerning higher education.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 21-12-6-7, AS AMENDED BY P.L.215-2018(ss),
2	SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	JULY 1, 2020]: Sec. 7. (a) Subject to IC 21-12-13-2, a scholarship
4	awarded under section 6 of this chapter or this section may be renewed.
5	To qualify for a scholarship renewal, a scholarship recipient must do
6	the following:
7	(1) Submit to the commission a renewal application that contains
8	all the information and evidence required by the commission to
9	determine eligibility for the scholarship renewal.
0	(2) Continue to be enrolled as a full-time student in good standing
1	at an eligible institution.
2	(3) This subdivision applies only to applicants who initially enroll
3	in the program under section 5 of this chapter or IC 21-12-6.5-2
4	after June 30, 2011. For purposes of this chapter, applicants who
5	are enrolled in the program before July 1, 2011, will not have an
6	income or financial resources test applied to them when they
7	subsequently apply to renew a scholarship. Continue to have a

1	lack of financial resources reasonably available to the applicant,
2	as defined by the commission, that, in the absence of an award
3	under this chapter, would deter the scholarship applicant from
4	completing the applicant's education at the approved

7	(4) Maintain satisfactory academic progress, as determined by the
8	eligible institution.
9	(5) If the student initially enrolls in an eligible institution for an
10	academic year beginning after August 31, 2019, complete a
11	student success program designed by the commission in
12	coordination with eligible institutions.
13	(6) Beginning in an academic year beginning after August 31,
14	2017, the student successfully completes:
15	(A) at least thirty (30) credit hours or the equivalent during the
16	last academic year in which the student received state financial
17	aid; or
