### **SENATE BILL No. 434**

DIGEST OF SB 434 (Updated January 29, 2020 4:19 pm - DI 133)

**Citations Affected:** IC 4-31; IC 35-31.5; IC 35-45.

**Synopsis:** Private card games. Defines "private low stakes card game" and provides a defense to certain gambling crimes if the gambling was a private low stakes card game. Defines "cheating" and makes cheating at gambling a Class A misdemeanor, and increases the penalty for the offense based on the gain obtained by cheating. Makes conforming amendments.

Effective: July 1, 2020.
