4 *Whereas, On October 29, 2016, the Carroll High School*
5 *boys cross country team won its first IHSAA state*
6 *championship title at the LaVern Gibson Championship Cross*
7 *Country Course in Terre Haute, Indiana;*

8 *Whereas, After completing an undefeated regular season,*
9 *the Carroll High School boys cross country team won the*
10 *Sectional, Regional, and Semi-State meets;*

11 *Whereas, At the 2016 IHSAA state championship meet, the*
12 *Carroll High School boys team tallied 71 points to take top*
13 *honors over defending state champion Carmel High School;*

14 *Whereas, The team was led by sophomore Cole Powers'*
15 *10th place finish, and senior Carter Meyer's 17th place finish,*
16 *earning both All State Honors;*

17 *Whereas, Also contributing to the Chargers team score*
18 *were sophomore Draven Thompson, junior Connor Goetz, and*
19 *senior Dawson Winters, followed by senior Braden Clements*
20 *and sophomore Cory Waldron;*

21 *Whereas, Zachary Sorg, Jack Just, Weston Miser, Cooper*
22 *Green, Chase Miguel, and Hunter Wallace were also members*

2 *Whereas, The Carroll High School boys cross country team*
3 *is coached by Phil Yoder and David Brooks;*

4 *Whereas, The members of the Carroll High School boys*
5 *cross country team are student-athletes who balanced countless*
6 *hours of cross country training, meets, and competitions on top*
7 *of a full academic course load;*

8 *Whereas, The Indiana General Assembly commends these*
9 *state championship winning student-athletes on their hard*
10 *work, integrity, and commitment to both academics and*
11 *athletics; and*
