10 *Joseph High School in the State Championship game;*

13 *in a header goal by Annah Hopkins in the eleventh minute of*
14 *play;*

15 *Whereas, Laurie Hargis tipped a ball from outside the box*
16 *to freshman Hope Lensing, who fired a strike for a goal at the*
17 *beginning of the second half;*

18 *Whereas, Grace Lensing fired a header into the goal with*
19 *nine seconds left, resulting in a final score of three to one;*
