## SENATE CONCURRENT RESOLUTION No. 15

---

1           A CONCURRENT RESOLUTION urging the  
2 establishment of the Office of Outdoor Recreation  
3 Development within the Indiana Destination Development  
4 Corporation.

5           *Whereas, The critical importance of Indiana's outdoor*  
6 *recreation industry for tourism and economic development*  
7 *cannot be overstated: 143,000 jobs for Hoosiers, \$15.7 billion*  
8 *in annual consumer spending, and \$1.1 billion in state and*  
9 *local tax revenue generated annually;*

10           *Whereas, Indiana's outdoor recreation industry not only*  
11 *includes state parks, trails, and water and snow resources, but*  
12 *many different activities and outdoor sports including hunting,*  
13 *fishing, camping, bicycling, boating, horseback riding, and*  
14 *motorcycling and other motorsports;*

15           *Whereas, Increased development and promotion of*  
16 *Indiana's outdoor recreation industry will create a better*  
17 *quality of place for Indiana residents and will attract potential*  
18 *residents to move to Indiana; and*

19           *Whereas, Establishing an office dedicated to developing*  
20 *and promoting Indiana's outdoor recreation industry is critical*  
21 *to the industry's future economic success: Therefore,*

22           *Be it resolved by the Senate of the General Assembly*  
23 *of the State of Indiana, the House of Representatives*

SC 15—RC 1532/DI AZ



1 SECTION 1. That the Indiana General Assembly urges the  
2 establishment of the Office of Outdoor Recreation  
3 Development ("Office") within the Indiana Destination  
4 Development Corporation established by IC 5-33-3-1.

5 SECTION 2. (a) As used in this section, "outdoor  
6 recreation" means a recreational activity that occurs outdoors in  
7 a natural environment, including the use of:

- 8 (1) trails;
- 9 (2) the natural landscape;
- 10 (3) water resources;
- 11 (4) snow resources; and
- 12 (5) other resources.

13 (b) If established, the Office should do the following:

- 14 (1) Increase outdoor recreation-based economic  
15 development, tourism, and ecotourism in Indiana by:
  - 16 (A) attracting outdoor recreation industries to  
17 Indiana;
  - 18 (B) developing the growth of new business  
19 opportunities in Indiana; and
  - 20 (C) marketing, advertising, and securing media  
21 opportunities that reflect the opportunities for  
22 outdoor recreation in Indiana.
- 23 (2) Promote the growth of the outdoor recreation  
24 economy in Indiana to support:
  - 25 (A) economic growth; and
  - 26 (B) stewardship and conservation of natural  
27 resources in Indiana.
- 28 (3) Coordinate with federal and state agencies and  
29 local government entities in Indiana on matters related  
30 to the purposes set forth in this section when the Office  
31 determines that coordination is necessary or beneficial.
- 32 (4) Recommend to the governor policies and initiatives  
33 to enhance recreational amenities and experiences in  
34 Indiana, help implement those policies and initiatives,  
35 and report on the impacts of implemented policies and  
36 initiatives, developing and supporting the development  
37 of data regarding the impacts of outdoor recreation in  
38 Indiana while ensuring national data are used as a  
39 benchmark factor in agency decisionmaking.
- 40 (5) Promote the health and social benefits of outdoor



- 1 recreation.
- 2 (6) Advocate on behalf of Indiana for federal funding
- 3 and participation in federal programs, including any
- 4 funding opportunities that are available through:
  - 5 (A) the Land and Water Conservation Fund
  - 6 established by 54 U.S.C. 200302;
  - 7 (B) the Sport Fish Restoration Program; and
  - 8 (C) the National Forest System Trail Stewardship
  - 9 Partnership Funding Program.
- 10 (7) Create and maintain a statewide list of lands to be
- 11 conserved, enhanced, and publicized for outdoor
- 12 recreation.

13 SECTION 3. The Secretary of the Senate is hereby directed  
14 to transmit copies of this Resolution to Governor Eric  
15 Holcomb, Lieutenant Governor Suzanne Crouch, and Elaine  
16 Bedel, Secretary and Chief Executive Officer of the Indiana  
17 Destination Development Corporation.
