1 A CONCURRENT RESOLUTION honoring Feldun Purdue
2 Agricultural Center on its 100-year anniversary, and urging the Indiana
3 Department of Transportation to consider signage commemorating the
4 Feldun Purdue Agricultural Center's sustained presence and service to
5 south-central Indiana and Hoosier farmers.

6 *Whereas, Moses Fell Dunn, a highly regarded lawyer and member*
7 *of the state legislature, donated 360 acres of land to Purdue University*
8 *in 1914;*

9 *Whereas, Feldun Purdue Agricultural Center was established as*
10 *Indiana's first "experiment station" outside of Tippecanoe County, and*
11 *is Purdue University's oldest research farm outside of Tippecanoe*
12 *County;*

13 *Whereas, From the original 360 acres of land, Feldun Purdue*
14 *Agricultural Center has grown to more than 900 acres of land in*
15 *Lawrence County, Indiana;*

16 *Whereas, Research at Feldun Purdue Agricultural Center focuses*
17 *on commercial beefcattle breeding and management, but also includes*
18 *studies of growth, yield, and cutting alternatives for upland central*
19 *hardwoods and grazing research, limited agronomic field studies with*
20 *row crops, and entomology; and*

21 *Whereas, The research performed at Feldun Purdue Agricultural*
22 *Center has been said to have done more to improve the beef cattle in*
23 *southern Indiana than any other single endeavor: Therefore,*

24 *Be it resolved by the Senate of the General Assembly*
25 *of the State of Indiana, the House of Representatives concurring:*



1 SECTION 1. That the Indiana General Assembly honors and
2 congratulates the Feldun Purdue Agricultural Center on its 100-year
3 anniversary.

4 SECTION 2. That the Indiana General Assembly urges the Indiana
5 Department of Transportation to consider signage commemorating the
6 Feldun Purdue Agricultural Center's sustained presence and service to
7 all Hoosier farmers.
