1 A CONCURRENT RESOLUTION honoring Pamela
2 Landwer on the occasion of her retirement from the Legislative
3 Services Agency.

4 *Whereas, After 34 years of dedicated service to the Indiana*
5 *General Assembly and the Legislative Services Agency, Pamela*
6 *Landwer is retiring;*

7 *Whereas, Pamela has served the Office of Bill Drafting and*
8 *Research as its office manager with great distinction and*
9 *helped to ensure that the office provides the independent,*
10 *objective, nonpartisan, and professional service expected of the*
11 *Legislative Services Agency;*

12 *Whereas, During these 34 years of dedicated service, Pamela*
13 *has been instrumental in the adoption and implementation of*
14 *the computer technology that has increased the capacity of the*
15 *Office of Bill Drafting and Research to produce bills and other*
16 *documents for the Indiana General Assembly;*

17 *Whereas, Pamela has long coordinated the process of*
18 *updating bill digests to reflect changes made as bills move*
19 *through the legislative process so that bill presentations have*
20 *not begun with a comment on the correctness of the digest for*
21 *more than 20 years and the content of the bill digests is rarely*
22 *remarked upon during floor debates;*

23 *Whereas, Pamela has tracked the committee and floor*
24 *debates in both the House of Representatives and the Senate so*
25 *closely throughout her career that it is hard to imagine that*
26 *anyone has paid greater attention to the actions of the Indiana*



1 *General Assembly over that time;*

2 *Whereas, Pamela is highly regarded for her "eagle eye",*
3 *superior attention to detail, and untiring work ethic;*

4 *Whereas, Pamela has drafted thousands of resolutions for*
5 *members of the Indiana General Assembly, and it is altogether*
6 *fitting that the Indiana General Assembly honor her through*
7 *this resolution; and*

8 *Whereas, Even though Pamela Landwer will be leaving the*
9 *Legislative Services Agency for the joys of retirement and more*
10 *time with her family, she will be greatly missed by all her*
11 *colleagues at the Legislative Services Agency: Therefore,*

12 *Be it resolved by the Senate*
13 *of the General Assembly of the State of Indiana,*
14 *the House of Representatives concurring:*

15 SECTION 1. That the Indiana General Assembly thanks
16 Pamela Landwer for her years of dedicated service to the
17 Indiana General Assembly and wishes her a long, happy, and
