1 A CONCURRENT RESOLUTION honoring Indiana's last
2 elected State Superintendent of Public Instruction, Dr. Jennifer
3 McCormick, on her retirement.

4 *Whereas, Dr. Jennifer McCormick is Indiana's 44th*
5 *Superintendent of Public Instruction;*

6 *Whereas, Dr. McCormick will be Indiana's final elected*
7 *State Superintendent of Public Instruction when her term ends*
8 *in 2020;*

9 *Whereas, Dr. McCormick is a lifelong Hoosier and*
10 *currently resides in Indianapolis, IN;*

11 *Whereas, She earned her bachelor's degree in elementary*
12 *education from Purdue University in 1993, her master's degree*
13 *in special education from Ball State University in 1999, and*
14 *finally her Ph.D. in educational leadership from Indiana State*
15 *University in 2011;*

16 *Whereas, Dr. McCormick has won many awards during her*
17 *time as an educator including, the Outstanding Contributor to*
18 *Education Award from the Muncie Delaware County Chamber*
19 *of Commerce and the 2013: Person of the Year, Yorktown*
20 *Chamber of Commerce;*

21 *Whereas, After serving in every level of K-12 public*
22 *instruction in Indiana, including the classroom and*
23 *administrative roles, Dr. McCormick ran for and won the State*



1 *Superintendent's office in 2016;*

2 *Whereas, Dr. McCormick has fulfilled her promises to the*
3 *state of Indiana remaining non-partisan in her role as Indiana's*
4 *chief education officer and has demonstrated her unending*
5 *support of Hoosier teachers in their fight for support from state*
6 *government and a fair, living wage; and*

7 *Whereas, The General Assembly wishes to honor Dr.*
8 *McCormick for her role as Indiana's Superintendent of Public*
9 *Instruction. Her efforts to ensure young Hoosiers receive the*
10 *highest quality education possible should be recognized:*
11 *Therefore,*

12 *Be it resolved by the Senate of the General Assembly*
13 *of the State of Indiana, the House of Representatives*
14 *concurring:*

15 SECTION 1. That the Indiana General Assembly honors
16 Dr. Jennifer McCormick, Indiana's last elected Superintendent
17 of Public Instruction on her retirement.
