6 *established in 1984 by Roosevelt Haywood III, a*
7 *second-generation insurance professional, who started in the*
8 *business at an early age working in his father's agency,*
9 *Haywood Insurance;*

10 *Whereas, Haywood and Fleming Associates has developed*
11 *considerable experience in serving the insurance and risk*
12 *management needs of large and complex commercial accounts;*

13 *Whereas, The city of Gary, the Gary Community School*
14 *Corporation, the Gary Sanitary District, NiSource/Nipsco,*
15 *Powers & Sons Construction, the Gary Chicago International*
16 *Airport, the Regional Development Authority, Methodist*
