MADAM PRESIDENT:

I offer the following resolution and move its adoption:

1 A SENATE RESOLUTION memorializing Harvey
2 Lambright.

3 *Whereas, Harvey Lambright of Howe, Indiana, passed*
4 *away February 17, 2019, at the age of 87;*

5 *Whereas, Born on September 23, 1931, to Charles and*
6 *Elizabeth, Harvey served in the United States Navy from 1951*
7 *until 1955;*

8 *Whereas, Harvey married Patricia Lewis on October 14,*
9 *1956, and together they raised three daughters;*

10 *Whereas, After graduating from the Reppert School of*
11 *Auctioneering, he began his career as an auctioneer, starting*
12 *what became Lewis and Lambright Auctioneers and Realtors*
13 *with his father-in-law;*

14 *Whereas, Every Wednesday, one could find Harvey working*
15 *at Shipshewana Antique Auctions, where he worked each*
16 *Wednesday for 64 years;*

17 *Whereas, Over the course of his lifetime, Harvey served as*

1 *president of the Indiana Auctioneers Association, the National*
2 *Auctioneers Association, and the Northeastern Indiana Board*
3 *of Realtors, and served 16 years as a member of the Indiana*
4 *Auctioneer Commission, serving three years as Chairman, and*
5 *as LaGrange County Republican Party Chairman for over 20*
6 *years;*

7 *Whereas, Harvey's numerous accomplishments include*
8 *being named a Sagamore of the Wabash in 1975 by Governor*
9 *Otis Bowen, named the 1970 Realtor of the Year by the*
10 *Northeastern Indiana Board of Realtors, inducted into the*
11 *Indiana Auctioneers Association Hall of Fame in 1982, and*
12 *inducted into the National Auctioneers Association Hall of*
13 *Fame in 1984; and*

14 *Whereas, Preceded in death by his wife of 59 years, his*
15 *parents, a sister, and a brother, Harvey is survived by his*
16 *daughters, Debra, Denise, and Dodie, three sisters, Wilma,*
17 *Amanda, and Katie, and a brother, Freeman: Therefore,*
