AN ACT concerning the disposition of state surplus real property; authorizing the department of administration on behalf of various state agencies to sell certain real property.

Be it enacted by the Legislature of the State of Kansas:

Section 1. (a) The department of administration is hereby authorized and empowered, for and on behalf of various state agencies to sell and convey all of the rights, title and interest subject to all easements and appurtenances in the following described real property:

- (b) Conveyance of such rights, title and interest in such real estate shall be executed in the name of the department of administration by the secretary of administration. Notwithstanding the provisions of K.S.A. 2016 Supp. 75-6609, and amendments thereto, all proceeds from the sale and conveyance thereof shall be deposited in the state general fund.
- (c) No conveyance of real estate authorized by this section shall be made or accepted by the department of administration until the deeds, titles and conveyances have been reviewed and approved by the attorney general. In the event that the department of administration determines that

the legal description of the real estate described in this section is incorrect, the department of administration may convey the property utilizing the correct legal description, but the deed conveying the property shall be subject to the approval of the attorney general. The conveyance authorized by this section shall not be subject to the provisions of K.S.A. 75-3043a, and amendments thereto, or K.S.A. 2016 Supp. 75-6609, and amendments thereto.

Sec. 2. This act shall take effect and be in force from and after its publication in the statute book.
