

HOUSE BILL No. 2467

By Committee on Appropriations

1 AN ACT making and concerning appropriations for the fiscal years ending
2 June 30, 2018, and June 30, 2019, for the department of education.

3
4 *Be it enacted by the Legislature of the State of Kansas:*

5 Section 1. (a) For the fiscal years ending June 30, 2018, and June 30,
6 2019, appropriations are hereby made, restrictions and limitations are
7 hereby imposed, and transfers, capital improvement projects, fees,
8 receipts, disbursements, procedures and acts incidental to the foregoing are
9 hereby directed or authorized as provided in this act.

10 (b) This act shall not be subject to the provisions of K.S.A. 75-
11 6702(a), and amendments thereto.

12 (c) The appropriations made by this act shall not be subject to the
13 provisions of K.S.A. 46-155, and amendments thereto.

15 DEPARTMENT OF EDUCATION

16 (a) There is appropriated for the above agency from the state general
17 fund for the fiscal year ending June 30, 2018, the following:

18 KPERS – employer contributions (652-00-1000-0100).....	\$2,804,000
19 KPERS – employer contributions – USDs (652-00-1000-0110)	
20	\$15,257,000

21 (b) On the effective date of this act, of the \$480,920,922 appropriated
22 for the above agency for the fiscal year ending June 30, 2018, by section
23 1(a) of chapter 95 of the 2017 Session Laws of Kansas from the state
24 general fund in the supplemental state aid account (652-00-1000-0840),
25 the sum of \$26,420,922 is hereby lapsed.

27 DEPARTMENT OF EDUCATION

28 (a) There is appropriated for the above agency from the state general
29 fund for the fiscal year ending June 30, 2019, the following:

30 KPERS – employer contributions (652-00-1000-0100).....	\$4,632,000
31 KPERS – employer contributions – USDs (652-00-1000-0110)	
32	\$26,147,000
33 Special education services aid (652-00-1000-0700).....	\$5,000,000
34 Education super highway.....	\$3,000,000
35 CTE credentialing assessments.....	\$105,000

36 *Provided*, That all expenditures from the CTE credentialing assessments

1 account shall be made to pay for the costs of industry-recognized
 2 credential assessments administered to students who have not attained a
 3 high school diploma and are enrolled in a school district: *Provided further*,
 4 That, notwithstanding the provisions of K.S.A. 2017 Supp. 72-3819, and
 5 amendments thereto, or any other statute, no student shall be required to
 6 pay for the cost of such assessment or any portion thereof: *And provided*
 7 *further*, That, if the amount of appropriations for the payment of industry-
 8 recognized credential assessments under this proviso is insufficient to pay
 9 in full the amount of such assessments during the fiscal year ending June
 10 30, 2019, then the state board of education shall prorate the amount
 11 appropriated among all school districts that are eligible to receive moneys
 12 in proportion to the amount each school district paid for such assessments.

13 (b) There is appropriated for the above agency from the children's
 14 initiatives fund for the fiscal year ending June 30, 2019, the following:
 15 CIF grants (652-00-2000-2408).....\$2,343,930
 16 Quality initiative infants and toddlers (652-00-2000-2420).....\$69,534
 17 Early childhood block grant autism diagnosis (652-00-2000-2422)...\$6,953
 18 Communities aligned in early development and education.....\$1,000,000

19 (c) On July 1, 2018, of the \$486,109,284 appropriated for the above
 20 agency for the fiscal year ending June 30, 2019, by section 2(a) of chapter
 21 95 of the 2017 Session Laws of Kansas from the state general fund in the
 22 supplemental state aid account (652-00-1000-0840), the sum of
 23 \$2,186,284 is hereby lapsed.

24 (d) On July 1, 2018, the \$50,000 appropriated for the above agency
 25 for the fiscal year ending June 30, 2019, by section 2(a) of chapter 95 of
 26 the 2017 Session Laws of Kansas from the state general fund in the
 27 incentive for technical education account (652-00-1000-0130), is hereby
 28 lapsed.

29 (e) On July 1, 2018, the amount of \$2,500,000 authorized by section
 30 2(b) of chapter 95 of the 2017 Session Laws of Kansas to be transferred by
 31 the director of accounts and reports on July 1, 2018, October 1, 2018,
 32 January 1, 2019, and April 1, 2019, from the state highway fund of the
 33 department of transportation to the special education transportation
 34 weighting – state highway fund (652-00-2223-2223) of the department of
 35 education on such dates, is hereby decreased to \$1,250,000.

36 Sec. 4. If any fund or account name described by words and the
 37 numerical accounting code that follows such fund or account name do not
 38 match, it shall be conclusively presumed that the legislature intended that
 39 the fund or account name described by words is the correct fund or
 40 account name, and such fund or account name described by words shall
 41 control over a contradictory or incorrect numerical accounting code.

42 Sec. 5. *Severability*. If any provision or clause of this act or
 43 application thereof to any person or circumstance is held invalid, such

1 invalidity shall not affect other provisions or applications of the act that
2 can be given effect without the invalid provision or application, and to this
3 end the provisions of this act are declared to be severable.

4 Sec. 6. *Appeals to exceed expenditure limitations.* (a) Upon written
5 application to the governor and approval of the state finance council,
6 expenditures from special revenue funds may exceed the amounts
7 specified in this act.

8 (b) This section shall not apply to the expanded lottery act revenues
9 fund, the state economic development initiatives fund, the children's
10 initiatives fund, the state water plan fund or the Kansas endowment for
11 youth fund, or to any account of any of such funds.

12 Sec. 7. This act shall take effect and be in force from and after its
13 publication in the Kansas register.
