1 AN ACT concerning the Kansas department for aging and disability
2 services; relating to Larned state hospital and Osawatomie state
3 hospital; catchment areas; amending K.S.A. 2016 Supp. 39-1602 and
4 repealing the existing section.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 2016 Supp. 39-1602 is hereby amended to read as
8 follows: 39-1602. As used in K.S.A. 39-1601 through 39-1612, and
9 amendments thereto:

10 (a) "Targeted population" means the population group designated by
11 rules and regulations of the secretary as most in need of mental health
12 services which are funded, in whole or in part, by state or other public
13 funding sources, which group shall include adults with severe and
14 persistent mental illness, severely emotionally disturbed children and
15 adolescents, and other individuals at risk of requiring institutional care.

16 (b) "Community based mental health services" includes, but is not
17 limited to, evaluation and diagnosis, case management services, mental
18 health inpatient and outpatient services, prescription and management of
19 psychotropic medication, prevention, education, consultation, treatment
20 and rehabilitation services, twenty-four-hour emergency services, and any
21 facilities required therefor, which are provided within one or more local
22 communities in order to provide a continuum of care and support services
23 to enable mentally ill persons, including targeted population members, to
24 function outside of inpatient institutions to the extent of their capabilities.
25 Community based mental health services also include assistance in
26 securing employment services, housing services, medical and dental care,
27 and other support services.

28 (c) "Mental health center" means any community mental health
29 center organized pursuant to the provisions of K.S.A. 19-4001-~~to~~ through
30 19-4015, inclusive, and amendments thereto, or mental health clinic
31 organized pursuant to the provisions of K.S.A. 65-211 to 65-215,
32 inclusive, and amendments thereto, and licensed in accordance with the
33 provisions of K.S.A. 75-3307b, and amendments thereto.

34 (d) "Secretary" means the secretary for aging and disability services.

35 (e) "Department" means the Kansas department for aging and
36 disability services.

1 (f) "State psychiatric hospital" means Osawatomic state hospital,
2 Rainbow mental health facility or Larned state hospital.

3 (g) "Mental health reform phased program" means the program in
4 three phases for the implementation of mental health reform in Kansas as
5 follows:

6 (1) The first phase covers the counties in the Osawatomic state
7 hospital catchment area and is to commence on July 1, 1990, and is to be
8 completed by June 30, 1994;

9 (2) the second phase covers the counties in the Topeka state hospital
10 catchment area and is to commence on July 1, 1992, and is to be
11 completed by June 30, 1996; and

12 (3) the third phase covers the counties in the Larned state hospital
13 catchment area and is to commence on July 1, 1993, and is to be
14 completed by June 30, 1997.

15 (h) "Screening" means the process performed by a participating
16 community mental health center, pursuant to a contract entered into with
17 the secretary under K.S.A. 39-1610, and amendments thereto, to determine
18 whether a person, under either voluntary or involuntary procedures, can be
19 evaluated or treated, or can be both evaluated and treated, in the
20 community or should be referred to the appropriate state psychiatric
21 hospital for such treatment or evaluation or for both treatment and
22 evaluation.

23 (i)—"~~Osawatomic state hospital catchment area~~" means, except as
24 otherwise defined by rules and regulations of the secretary adopted
25 pursuant to K.S.A. 39-1613, and amendments thereto, the area composed
26 of the following counties: Allen, Anderson, Atchison, Bourbon, Brown,
27 Butler, Chase, Chautauqua, Cherokee, Clay, Coffey, Cowley, Crawford,
28 Doniphan, Douglas, Elk, Franklin, Geary, Greenwood, Jackson, Jefferson,
29 Jewell, Johnson, Labette, Leavenworth, Linn, Lyon, Marshall, Miami,
30 Mitchell, Montgomery, Morris, Nemaha, Neosho, Osage, Pottawatomie,
31 Republic, Riley, Sedgwick, Shawnee, Wabaunsee, Washington, Wilson,
32 Woodson and Wyandotte.

33 (j)—"~~Larned state hospital catchment area~~" means, except as otherwise
34 defined by rules and regulations of the secretary adopted pursuant to
35 K.S.A. 39-1613, and amendments thereto, the area composed of the
36 following counties: Barber, Barton, Cheyenne, Clark, Comanche, Decatur,
37 Dickinson, Edwards, Ellis, Ellsworth, Finney, Ford, Gove, Graham, Grant,
38 Gray, Greeley, Hamilton, Harper, Harvey, Haskell, Hodgeman, Kearny,
39 Kingman, Kiowa, Lane, Lincoln, Logan, Marion, McPherson, Meade,
40 Morton, Ness, Norton, Osborne, Pawnee, Phillips, Pratt, Rawlins, Reno,
41 Rice, Rooks, Rush, Russell, Saline, Scott, Seward, Sheridan, Sherman,
42 Smith, Stafford, Stanton, Stevens, Sumner, Thomas, Trego, Wallace and
43 Wichita.

1 ~~(k)~~ "Catchment area" means the Osawatomie state hospital catchment
2 area or the Larned state hospital catchment area.

3 ~~(j)~~ "Participating mental health center" means a mental health
4 center which has entered into a contract with the secretary for aging and
5 disability services to provide screening, treatment and evaluation, court
6 ordered evaluation and other treatment services pursuant to the care and
7 treatment act for mentally ill persons, in keeping with the phased concept
8 of the mental health reform act.

9 Sec. 2. K.S.A. 2016 Supp. 39-1602 is hereby repealed.

10 Sec. 3. This act shall take effect and be in force from and after its
11 publication in the statute book.
